Belmore Arena Board Meeting - Monday, November 21, 2022

Randy called the meeting to order at 8:05pm.

Motion to accept meeting agenda made by Nigel Van Dyk, seconded by Warren Weber.

Randy asked for any errors or omissions within the minutes from the October 17, 2022 meeting received via email prior to this meeting. None noted. Minutes accepted by Warren Weber, seconded Nigel Van Dyk.

Business Arising From Last Meeting:

- Jeremy reported he was emailing back and for with J-K re: sandblasting issues
 - Hoping J-K would come back in the spring and touch up areas with no paint coverage and around doors.
 - J-K indicated he would do that, but would need more money than what is being held back.
 - We are holding back approx. \$20,000 \$25,000
 - Jeremy then spoke to Howick Township and they agree we are going about this in the correct way.
 Advised us to document everything.
 - Jeremy also spoke to Burnside as they were the ones who suggested we needed to have sandblasting and painting done. The also feel we are going about things in the right way.
 - Arena Board could cover cost of lift rental, but we won't be paying J-K more than what is being held back.

Treasurer Report:

- Nigel presented his report, bills to be paid this month total \$12,787.08.
 - Noting a \$6,647.27 invoice for Kore Mechanical for repairing the ice plant.
 - o Nigel shared the amounts donated "in memory of", for different individuals
 - o Ian Inglis made a motion to pay bills, seconded by Kim Harris. Carried.
- Treasurer's report attached to minutes.
- Edwards sent another bill for oil
 - Nigel was in contact with them to remind them about coming back to pump oil out of tank they
 weren't to deliver, also that our water heater and furnace are gone.
 - They are to get us an updated invoice soon
 - Edwards advised they would buy the oil tank back from us
 - Everyone in favour of selling the oil tank

Grants:

- Re: \$2,500.00 grant from South Bruce - Kyra completing necessary form and providing invoices for the curling scoreboards, curling bench structure, lobby bench-top upgrades. This needs to be into South Bruce by December 1st and hopefully will receive our cheque in December.

Belmore Catering:

- Flannigan Wholesale Foods account was approved and now in place.

General Maintenance:

- Ice Plant has been started

- Warren still to call Dave Huber to see if he is willing to prime & paint all hallway walls and ceiling and lobby in the spring
- Chris Inglis and Janet Marston did the Christmas planters at the front of the building
 - o Kim motioned that Chris and Janet's invoices be paid. All in favour.

- Gord Harris found a truck body container online
 - o 24' container for \$3,300.00
 - This would be a good way to store tables and chairs that aren't in use
 - o Should we be looking at purchasing?
 - Chris made a motion that Kim and Gord should look into availability of container, seconded by Kyra. Carried
- Defibrillators checked by Dave Wagner, Wingham
- AC switch in hall has been labelled
- Mass email was sent out in regards to Smart Serve course.
 - o 22 people expressed interest
 - o Kim is hoping the course can be held in January or February
 - Kim will arrange a Facilitator
 - Cost for Facilitator is \$180.00
