From The Board:

Kirkwood Lift Station Diversion and Abandonment update

The City of Houston is abandoning the existing sanitary sewer lift station on the east side of Kirkwood, south of the Buffalo Bayou Bridge by rerouting the sewers west to the Harvest Moon Lift Station near Dairy Ashford. Construction has commenced. The project will be constructed in phases starting at the Harvest Moon Lift Station and working east to Kirkwood. (But not through Country Village) The last phase will occur at Kirkwood from the fall of 2020 to the spring of 2021.

Kirkwood Paving and Drainage Project update

This project will reconstruct Kirkwood Road from Buffalo Bayou to Westheimer Road in two projects, and add substantial in-line detention underneath the new roadway. The first phase goes from Buffalo Bayou through the Briar Forest intersection. Construction will start in the first quarter of 2020. A community preconstruction meeting will be announced soon by the Councilman's office. The second phase may begin in 2022.

Riverview Cut-thru Traffic

To address the increased cut-thru traffic on Riverview, the City was asked about changing the 2-way to 4-way Stop sign at Heathwood and Riverview. The City conducted a field investigation on 08/12/19 at 3PM. The stop signs were found in good condition, correctly oriented with no view obstructions. A 1 hour preliminary intersection field traffic volume count was conducted for Heathwood that found a total of 21 vehicles and 68 vehicles for Riverview. Speed cushions and road humps were found for Riverview between Kirkwood and Briar Forest with corresponding road hump with 20-MPH speed advisory warning signs posted at both entrances.

A check of the City records determined that a 4-way Stop investigation was previously conducted for this location in 2017 that was declined due to insufficient traffic volume or accident history to meet the Texas Manual for Uniform Traffic Control Devises (TMUTCD) minimum requirements.

Specific guidelines established by (TMUTCD) that the City must follow states that Stop signs are not intended for use to deter speeding or cut-thru traffic and are intended to assign right of way at uncontrolled intersections. The (TMUTCD) further states that a minimum traffic volume for the primary street of 300 vehicles (continued on next page)

per hour for 8-one hour periods per day and 200 vehicles for the secondary street per hour for 8-one hour periods for the same day, or a 12-month accident history of 5 or more recorded incidents is needed in order to qualify for a change in Stop sign control. A change in Stop sign control for this location is not recommended based on insufficient traffic volume or accident history to meet minimum (TMUTCD) guidelines. City's recommendations: A request would be forwarded to (HPD) to conduct speed enforcement for Riverview Dr. between Kirkwood and Briar Forest targeting morning and afternoon prime drive times subject to neighborhood concern.

Linear Detention along the south side of Buffalo Bayou from Dairy Ashford to Eldridge

Construction began in July 2019 and should finish this year. HCFCD anticipates this is a pilot to gauge public response and support for possible additional channel excavation in Terry Hershey Park.

Buffalo Bayou study of Oxbows and Bridges inside Beltway 8

HCFCD reported on October 16 that their study revealed only minor benefit was gained for addressing low bridges and oxbows due to inherent resistance in the bayou from Beltway 8 to Shepherd. The improved benefit would be less than 6 inches and cost \$127 million. Multiple bridges downtown create significant restriction but were judged too expensive and difficult to address. An alternative to relieving constrictions in the bayou east of BW-8 is that of additional excavating the existing Buffalo Bayou/Terry Hershey Park from Beltway 8 to Highway 6.

Super Neighborhood 18

Country Village is part of Super Neighborhood 18. There is a monthly meeting on the third Tuesday of the month. The meeting is now held at the Village Place Clubhouse at 11315 Lakeside Place Dr. The meeting is open to all residents. The next meeting is on February 18th from 6:30-8:00.

Architectural Control Committee
