TREE REMOVAL PROCEDURE FOR RESIDENT FUNDED REMOVAL

If a Resident has substantial reason to remove or prune a tree in the front yard and is willing to fund the work the following procedure must be followed. The HOA values our mature trees so decisions to remove must not be made lightly.

- 1. Fill out a request for Landscape Attention outlining what you would like to have done and the reasons for the changes, removal
- 2. State on the form that you are willing to fund the work
- 3. If the request is for minor pruning the Landscape committee can make the decision to allow the work to proceed.
- 4. If the request is for tree removal the request must be taken to the Board for approval
 - a. If the tree is the major tree in the front yard it must be replaced with another significant tree the type approved by the landscape committee and Board
 - b. There must be an imperative reason for the tree removal. (Just not liking the tree is not sufficient reason) such as damage to walkways or driveways from tree roots
 - c. The Agreement, "Agreement Regarding Removal of Trees" must be signed by the homeowner prior to work starting.

tree, and its stump, will be performed betw	een the hours of 8:00 a.m. a	and 5:00 p.m.
Homeowner(s) further agree(s) that upon c	ompletion of the removal of	the tree and stump, the tree
shall be replaced at Homeowner(s)' expens	se with a tree of a size and s	pecies approved by the HOA
Landscape Committee, and that Homeowr	ner(s)will repair any damage	to the lawn and landscape
resulting from said removal and replaceme	nt. It is further agreed that a	all work of removal and
replacement shall be done at Homeowner(s)' expense and further agre	ed that the replacement
tree shall be maintained by the HOA in acco	ordance with CC&Rs section	ns 5.1.A(2) and 6.3.
Homeowner(s) further agree(s) to p	rotect, indemnify and hold h	narmless HOA from any and
all claims, suits, or judgments, of any kind o	or nature, including attorney	s' fees and costs of suit,
which may arise from the work of removal o	of the tree, its stump, or repl	acement of the tree.
