My beautiful Tess is gone. She was four years, seven months and 5 days. My beautiful, way too smart, pain in the ass, I'll come in my own good time, thank you Tess, who had a bark like a Rottweiler, but that same bark meant "cuddle me" as much as it did "I'm gonna take you apart." She was a 35-pound lap dog who loved to cuddle. She was a guard dog who was ever diligent in getting behind me to tell me there was noise downstairs that I should investigate. A bird dog, a scent hound, a lure courser: when we moved to the country she showed attributes and potential of all these qualities. She was my pet; an easily trained bitch who had enormous potential had I the time and ability to work with her. Yet she was my constant companion with Jake, her half-uncle and "older brother," who wanted me to send her back the first week, then bonded so tightly that each was always near the other, and neither would come inside unless the other was there too.

Tess had a herding instinct that was evident when she was very young: once I took her in the ring for an actual test she had matured to the point where, taking one look at those big sheep and one look at me, she decided to stay beside her human. I had hoped to get her some lessons once things calmed down at the farm; now we will never know.

The vet said she had either a cardiac or a neurological event: we were in the yard, she had her leash on and I was getting ready to put my dogs in the car, when she jumped up with a cry, then was rolling on her back on the wet grass. Since she had had a bath a few days ago, I thought, oh no, dirty dog... When I saw her next she was lying a few feet away from the old red maple tree. I walked up to her-she was not moving and I thought she was "playing possum," why that phrase came to me I don't know—she was alive but unable to move, so I backed the car to where she was and barely managed to get her into the back seat. She was alive when we left for town but 8 minutes later when we pulled up at the vet's she was gone. Jake was in the back seat with her. He came into the vet's with me, and when I picked him up to say goodbye he looked away—he knew she was gone. That beautiful face, those amazingly expressive eyes—her spirit was gone-it was hard to say a prayer for her because it was clear she was already with God.

This is hard. I loved her so much and I thought the two of us would be together after Jake went to the Rainbow Bridge. I know I will see her in every corner; look up and wait for her to enter any room I am in. She was a gift from God, and I am struggling to accept that it was finite. Sleep well, Baby Girl, I love you.

More on Crime-Fighting Canines

This article first appeared in the November 2014 Seanachie but I visited the web site recently and discovered that a series of episodes is available to follow one of the classes through their training session. Click either the Virginia or Maryland teams to see the web series with Victoria Stilwell narrating.

Meet the Virginia and Maryland Arson dog teams. These canines are trained to detect the arsonist's tools of accelerants, and assist their handlers in investigating fire and bomb scenes. The Arson Dog Program was sponsored by State Farm Insurance in 1999, and over 325 dog teams have been placed in the United States and Canada. State Farm continues to sponsor teams that are likely to respond to at least 50 structure fires per year through an application process at the web site. The teams complete a fourweek training program in Maine, and must re-certify each year. Only ten new teams are trained each year, so the waiting list is long. The dogs also assist with publication education seminars on fire safety.

U.S. Army Remount Station Front Royal VA

In the last few months, I read two fascinating horse books by author Elizabeth Letts. (I'll related this to dogs at the end, so just hang on.)

Her book "The Eighty-Dollar Champion" is the story of Snowman, a horse purchased for eighty dollars from the back of a truck destined for a meat packing plant. Snowman became legendary in the equestrian world of the 1950's and 1960's.

The most recent book "The Perfect Horse" is the edge-of-your seat history of how the Austrian Lipizzaner stallions, mares, and foals from Austria during World War II as well as a great number of Arabian and other prime horse breeding stock were saved by the U.S. Army ground forces in Germany under General George S. Patton.

Patton and others of the U.S. Army Cavalry officers have historically competed in the U.S. Equestrian Olympic teams events. Following the Civil War, the U. S. Army realized the need to keep a supply of good horse stock in readiness should the need arise. The Army started the "Remount" program under which stallions with desirable breeding characteristics owned by the Army would be cheaply rented out for stud to suitable mares owned by farmers and ranchers. The Austrian Lipizzaners were returned to Austria, but the German Arabian and other horses were brought to the United States as "spoils of war" through the naval port at Newport News, VA and initially stabled at the Army Remount Station in Front Royal, VA.

The Army later reassigned the Remount program to the Department of Agriculture in 1948 and many of the horses were moved West.

Eventually the equine at Front Royal became the DHS Canine Training facility of today.
