The Calista Education and Culture, Inc. (CEC) Scholarship is funded by donations and fundraising through CEC. The scholarship program was established in 1994. CEC is an Alaska non-profit corporation, recognized by the IRS as a 501(c)(3) charitable organization and donors are eligible to receive tax deductible status on donations and gifts to CEC. All CEC scholarships are subject to the availability of funding.

### **ELIGIBILITY REQUIREMENTS**

Calista Corporation Original Shareholder or Direct Lineal Descendant: Applicant must be a Calista Corporation Original Shareholder or Direct Lineal Descendant (either natural born or legally adopted) of an Original Shareholder. Individuals who inherit or received gifted shares do not qualify as Original Shareholders. Applicants must submit a copy of their Bureau of Indian Affairs (BIA) Certificate Degree of Indian Blood (CDIB). Lineal Descendants must also submit a copy of their birth certificate.

High School Diploma or GED: Applicant must have a high school diploma or GED.

Grade Point Average (GPA): Applicant must have a cumulative GPA of 2.0 or higher. Official transcripts from colleges or universities attended must be submitted, or official transcripts from graduating high school or copy of GED, if no college or university has been attended.

Current Letter of Acceptance/Good Standing or Proof of Application: Applicant must be accepted to an accredited school (trade, vocational, college, university) or provide proof of application. A current (dated in current year) letter of acceptance/good standing or letter from the school stating the application for admission is currently under review must be submitted. A letter of acceptance must be submitted if an applicant is awarded a scholarship.

Enrollment Status: Applicants must be considered enrolled Full-time or Part-time based on the schools requirements.

Full-time - undergraduate students must be enrolled in 12 or more credits. Graduate students must be enrolled in 9 or more credits.

Part-time - undergraduate students must be enrolled in 6-11 credits. Graduate students must be enrolled in 2-8 credits.

#### SCHOLARSHIP AWARDS

Scholarship awards are awarded on a Fall and Spring Term basis in alignment with the application deadline. The scholarship may be used for tuition, books, and fees. The scholarship recipient must have a 2.0 or higher GPA and maintain and satisfactorily complete a full-time or part-time status for the entire semester/quarter they received the scholarship.
