NEW BUSINESS:

- **Masks are not consistently worn to in-person meetings**
 - Some chair people and/ or attendees decline to wear a mask despite the signage and the Group Conscious decision that in-person requires a mask at this time

- Those attending later meetings may not be aware of non-compliance at previous meetings and the group has not been properly sterilized between meetings
- Food items are also found left in the meeting rooms which is also prohibited at this time
- Kris D to issue reminder communication to all members
 - CAN Group Conscious voted on masks as a requirement for in-person meetings, and individual meetings are to adhere to the will of the overall Group Conscious
 - Individual members are encouraged to remind one another of current group protocol for those not wearing masks or eating in the facilities
- Routine non-compliance
 - If certain meeting times continue to observe refusal to the mask requirement, the Group Conscious will vote to decide if that in-person meeting time will be suspended until compliance resumes
