### ART! a little on the trashy side... 😊

A Recycled/Repurposed Art Exhibit

March 5th – May 4th, 2018

The theme of this exhibition is recycling, upcycling or repurposing. Using trash or discarded items or materials to make something new. All work must have a recycled or repurposed element. Think trash to treasure! Reuse of old books, magazines, photos, plastics, papers, found objects, reassembled, reconstructed or reused in a new and utterly different way is what this show is all about! Get creative and clever and have fun! This is a chance to try something NEW! Google upcycled or recycled art and click on images for lots of great ideas and inspiration!

Open call for artists. ALL artists are welcome to submit up to five (5) pieces for this exhibit. This exhibition is open for ALL mediums, 2-D, painting, collage, mixed media, printmaking, etc. or 3-D, sculpture, mixed media, assemblage, etc.

#### General Guidelines:

- Onetime \$35 jury fee is required for entry to this exhibition. Jury fee must be mailed to GVA or paid online before deadline for entrant to be eligible for exhibition.
- \$35 jury fee is waived for all GVA Members at the \$100 Artist Level or above.
- Artwork must be appropriately mounted or framed and ready to hang. No saw-tooth hangers. This means you must have at least a 5" wire across the back of your piece in order to hang it on our Walker Hanging System. Gallery wrap canvases must be painted on the sides and must be 1.25" or more in depth. THIS REQUIREMENT WILL BE STRICTLY ENFORCED.
- Artwork must be wholly original and created by the presenting artist. Works must not infringe on any rights, copyrights, trademark rights, rights of publicity, or proprietary rights of any other individual or entity. Work must have been created within the last year.
- Exhibition/Jury Committee has the right to refuse any works that are deemed inappropriate or not of good quality. This is a juried exhibition.

#### Submission Guidelines: **NEW! Please read carefully!**

- Artists may submit up to five (5) pieces of art.

- Subject line of e-mail should read: “Art on the Trashy Side”
- Body of email should include: Artist’s Name, Address, Phone #
- Attach & send images in jpg format. Images must be of high quality and named properly for acceptance.
- Name jpg images using the following format:
  - -2018ATS-“last name of artist”-“title of piece”.jpg.
  - Example: 2018ATS-Ryles-ShoeTrash.jpg
- If photos are shot on a phone please crop out all visual distractions and save in a high resolution format.

**Conditions of Exhibit:**

GVA requires a commission of 40% on all works sold. Payment to the artist/exhibitor for works sold, will be made by GVA, after a complete and accurate accounting, by the 20th of the following month. Every effort will be made to assure that the work exhibited is protected while in the custody of the GVA. However, the artist is responsible for all insurance on exhibited work.

**Publication Waiver:**

Entering artwork constitutes permission for GVA to use images and publish images of artwork as advertisement in print materials, the GVA website and other GVA social media outlets featuring the exhibition. Proper credit will be given to the artist in the event the artist’s images are used in any promotion materials.

**Terms of Entry:**

Submission of entry automatically constitutes the entrant’s acceptance of all jurying rules and criteria as stated here. Judge/jury decision is final and GVA WILL NOT entertain correspondence with respect to the results.

- Artists pick up artwork Saturday, May 5<sup>th</sup>, 2018 between 10:00am - 5:00pm. **All artwork must be picked up NO LATER than May 5<sup>th</sup>** by 5:00 p.m. unless prior arrangements have been made. After May 5<sup>th</sup> the artwork becomes the property of Glynn Visual Arts.
