Course Familiarization and Warm-Ups

Handlers are permitted to walk the course, without a dog, prior to the start of the class. The walkthrough is restricted to handlers entered in that class. Walkthroughs will be held prior to the Novice, Open, and Master/Excellent classes.

Entry Fees

each includes an AKC recording fee \$25-first entry, each dog, each day (\$3.50 AKC RF) \$14-each additional entry, each dog, same day (\$3 AKC RF)

Awards

Titling Classes: A green ribbon will be awarded to all dogs receiving a qualifying score. Rosettes will be awarded to qualifying dogs placing 1st - 4th (plus a dog toy valued at up to \$5) and to those completing titles. A large rosette and MACH bar will be awarded to teams completing a MACH title. A large rosette & PACH bar will be awarded to teams completing a PACH title. All awards must be claimed at the trial; none will be mailed.

Exhibitor Information

Club or AKC event clothing may be worn by anyone. Clothing may display the person's name, dog's call name &/or the dog's picture, but no titles. Writing or graphics must not be in poor taste or contain profanity. Clothing must not display any info that would be in conflict with a sponsor of the trial.

Junior Handlers

PLEASE be sure to indicate on the entry form whether a Junior handler will be running the dog, and also include their JH number and date of birth. It is now required to include this in the AKC catalogs, and addition after scoring of a trial has begun is difficult!

Hotel Information

The following hotels accept well-mannered dogs and handlers; some may charge additional fees for pets, so please call ahead to verify policies. Please clean up after your pets at the hotels! They are considered extensions of the show site, and we have requested they notify us of any problems so that appropriate actions may be taken.



Directions to the Trial and Show Site Information

Crating space: All crates and x-pens MUST have plastic or a tarp underneath them (please bring your own waterproof material!). Crates may be left overnight; however, neither CATC nor Resolute Athletic Complex will be responsible for lost/damaged items left at the site. No setup until Friday! No overnight parking or RVs will be allowed at the trial site.

Concessions: There will be food available on-site. There are also various restaurants and fast food vendors within a very short driving distance. No food is allowed in the turfed areas.

Directions: From all directions, take 1-270 to Exit 33 (Easton Way) on the East side of Columbus; turn West onto Easton Way to Sunbury Road (1.5mi); then turn right (North) onto Sunbury. Travel North for 0.3mi, then turn right (East) onto Chiller Lane. Resolute will be on your right (South).



Notice to Exhibitors

Safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely. **Puppies** under 4 months of age are prohibited from the show grounds.

All dogs must be on leash or confined except when being judged or when in the designated agility warm-up area.

Faxed, telegraphed, telephoned, e-mailed, unsigned entries, or entries **not on an official AKC** Agility entry form (or photocopy) with <u>signed Agreement</u> and Instructions attached cannot be accepted.

No entry shall be made and no entry shall be accepted which specifies any conditions as to its acceptance. **Express delivery entries** must include a signature permitting them to be left at the Trial Secretary's address <u>without the recipient's signature</u>. If no recipient is present to sign for receipt, entries may be returned to sender.

Entries will be acknowledged after entries close with identification numbers and a judging program. Should such acknowledgement not be received within a reasonable time, please contact the Trial Secretary. Confirmation of acceptance will be made if either an email address or a self-addressed, stamped postcard with checkboxes for each class entered is included with the entry.

Owners are responsible for **errors made while filling out entry forms**, whoever makes such errors. No entry fee will be refunded in the event of such errors or cancellation of entries after the published closing date. Please type or print carefully to minimize errors! Every effort will be made to find all **duplicate entries**; however, if an entry has been processed, no refund will be made.

Make all checks and money orders **payable to CATC** in US funds only. Please mail fees with entries. The Trial Secretary and CATC assume no responsibility for cash sent through the mail. **Postdated or returned checks** do not constitute a valid entry fee. There will be a \$20 service charge for returned checks.

Entry fees will not be refunded in the event that the dog is absent, disqualified, excused, or barred from competition by action of the event committee. No fees will be refunded if the trial cannot open or be completed in the event of riots, civil disturbances, fire, public emergency, act of a public enemy, or any other cause beyond the control of the trial committee. Entry fees less \$5 per run will be refunded for injured dogs or bitches in season on the day of the trial if veterinary certification is presented no later than 30 minutes before the start of judging. Overpayment of less than \$10 per dog per day will not be refunded except at the exhibitor's request.

Exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the trial site. In such case, no refund of any entry fees will be made.

Judges are not required to wait for any dog holding up a class. Handlers are responsible for the presence of their dogs in the judging ring when it is their turn to run. Dogs may arrive any time prior to their scheduled time of judging. Dogs not required for further judging will be excused.

Columbus All-breed Training Club and its agents assume **no responsibility for any loss, damage, or injury** sustained by exhibitors, handlers, their dogs or property, or their children.

Dogs Eligible to Enter

This trial is open to all dogs 15 months of age or older that are registered with the American Kennel Club, or that have AKC Limited Registration, Purebred Alternative Listing/indefinite Listing Privileges (PAL/ILP), or an AKC Canine Partners listing number, or approved Foundation Stock Services (FSS) breeds are eligible to participate.

Bitches in season, aggressive or blind dogs, or dogs suffering from any deformity, injury or illness which may affect the dog's physical or mental performance are ineligible to participate.

AVMA Health Statement

"Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations."

T2B is offered Sunday, in addition to he following classes/levels for both Regular & Preferred divisions:

STD & JWW Novice A/B (Reg); Nov(Pref) Open Master/Excellent Premier (STD & JWW; Friday only) FAST *(Saturday only)* Novice A/B (Reg); Nov(Pref) Open Master/Excellent

Dogs must be entered only in Preferred or in Regular classes, with no crossover between them being allowed at the same set of trials.

Obstacles

All obstacles will conform to requirements as specified in the current revision of the "Regulations for Agility Trials" from the American Kennel Club (available at www.akc.org).

Simplified Jump Height Card Process

When filling out the entry form, there is a new section at the top of the form to designate whether your dog has a valid jump height card or if your dog needs to be measured. Please check the appropriate box so that the Trial Secretary knows whether to include your dog on the **Dogs To Be Measured List**. It is no longer required that you submit a copy of your dog's jump height card with your entry form or show it during day of show check-in. It is solely the responsibility of the exhibitor to check the correct measurement box, enter your dog(s) in the correct jump height, have your dog(s) measured before running (if necessary), and to have your dog(s) height card(s) available to present, if requested.

Height Divisions

Owners are responsible for entering the proper division. All heights are as measured at the withers. <u>Only dogs measuring into the 8 thru 20" Regular divisions may optionally enter the 24C division</u>.

Regular Class (*Preferred Class*) jump height divisions:

8/4/inchesfor dogs 11 inches and under
12/8/inchesfor dogs 14 inches and under
16/12/inchesfor dogs 18 inches and under

20/16/inches.. for dogs 22 inches and under 24/20/inches.. for dogs over 22 inches 24C division .. at owner's discretion (*n/a Preferred*)

Dogs entered in **Preferred** classes <u>must</u> jump at a height 4" lower than the minimum height they would be required to jump in Regular classes as listed above.

First Received Entries

Entries for a maximum of 10 dogs are allowed in each envelope. No hand deliveries within first 24 hours after opening of entry period.

Move-Ups

Dogs may be moved up to a higher class at the request of the owner. This request must be made to the Trial Secretary by 6pm on Monday, Sept 24, by mail or e-mail (see form on p.9). Day-to-day moveups must be requested in writing at the trial site before the close of trial on the preceding day.

Confirmations, Corrections, Entry Changes, and E-mail

Per AKC regulations, changes to entries may be made until the closing date. After that time, only moveups are permitted until the moveup deadline. Corrections to entries due to Secretarial error may be requested at any time: however, any day of show corrections cannot be augranteed to be reported to AKC correctly!!. Preliminary confirmations will be emailed within 7 days of receipt of your entry if a valid email address is provided; PLEASE be sure to add Secretary@furrydogs.com to your address book/whitelist to ensure the email reaches you, so you can check your information promptly!

Wait List for Withdrawn Entries after the Closina Date/Time

CATC is offering a Wait List to fill openings created by withdrawn entries after the trial's closing date/ time. A maximum of 30 runs per trial day will be placed on the club's wait list. All entries, including waitlisted entries, must be received by the Trial Secretary prior to the normal closing date.

Any withdrawals that are received by 6pm Thursday, September 20 will be replaced by a waitlisted entry if any are available. If a withdrawn entry is replaced by a waitlisted entry, a full refund will be issued for the withdrawn entry. Withdrawals (except BIS or injury withdrawals) will not receive a refund if there are no waitlisted entries to backfill the withdrawn runs.

Any waitlisted entry that does not move off the wait list into the trial by the above final withdrawal deadline will receive a full refund of waitlisted runs.
