POLS 103: Introduction to American Politics Spring 2014

This course is an introduction to American national politics. The central premise is that nothing in politics happens by accident – everything you see is the result of the choices people make. The goal is to understand American politics by examining these choices and their consequences.

The secondary emphasis is on facts, both to provide basic information about American politics and to demonstrate that there is evidence behind the theories and arguments presented in the class. The class will be ruthlessly contemporary, emphasizing the political issues, campaigns, and controversies that are part of our everyday life.

While the class covers both the science of politics and the politics of the real world, it does not put a partisan spin on events. The class will focus on explaining how politics works without taking a position on whether one set of opinions or preferences are better than another. You are expected to follow this rule in your class participation and assignments.

The sole text is *American Politics Today* (third edition), which has been ordered for the class as an online text via Courseload. If you wish to purchase a hard copy, the ISBN for the paperback version is 0393913260. Please purchase the full edition, not the core edition, the essentials edition or the Texas edition. And do not purchase the first or section edition.

There will be a total of five exams – four during the semester and and one during finals. Two of the exams (2 and 4) will be taken on-line (that is, you can take the exam at home and do not have to show up for class on exam day); the remaining exams will be taken in-class. Exam 1 counts for 10 percent of your grade, exams 2 and 3 count for 15 percent, and exams 4 and 5 count for 20 percent. 5 percent of your grade will be determined by participation in chapter pretests. The final 10 percent of your grade will be determined by attendance in lecture and section.

Excused absences require a compelling reason – serious illness, a personal crisis that requires your immediate and undivided attention, or official university business. I reserve the final decision on whether an absence is excused or unexcused.

Finally, you are responsible for learning about and following IU's policy on academic dishonesty, including the proper use of sources in written material. I take these policies extremely seriously. Do not expect lenience if you violate these policies.
