Minutes for March's meeting were approved.

#### Pool:

- Shade:
  - Jennifer got additional quotes for baby pool shade 12x12x8 with a center post.
  - Sunguard quote is \$5800 with the best warranty and plans bolt through the concrete.
    Installing via an offset would cost another \$2450 which requires a footing. The board has requested additional information from Sunguard prior to making a decision:
    - Does the installation get a warranty?
    - If he only finds 4" of concrete, what is his solution since he intended to bolt the umbrella?
  - Maryland Materials quote is \$5100. They would need to dig footers and might have to take down part of the fence to do the work and will put it back up.
  - Little Tykes quote is \$6200 with digging.
  - The board will call for a vote at the additional grounds meeting on April 28 to move forward or not once the additional information is received from Sunguard.
- Board decided to wait until May meeting to decide about 5<sup>th</sup> grade pool party due to lack of information about Montgomery County's decision on the last day of school.
- Concrete: One quote \$4500 because it is a very small job and it is hard to find contractors. Still looking for other quotes. In addition, the companies have to be commercially licensed. Cheryl is continuing to get quotes.
