### Treasurer's Report

- Financial Report:

## New Business

**Open Discussion Regarding:** Request for the Advisory Council to consider moving a portion of its prudent reserve to an interest-bearing account.

## **Discussion:**

- I believe that the type of account is called a Business Money Market Account and would have about 3% interest. We would be able to access money whenever, but would only be able to remove money from it once per quarter. I would suggest placing \$10,000 into an interest bearing account like this.
- No clear issues with Traditions and Concepts.
- There is some precedence for this with how the General Service Board operates with investments, however, they are a multi-million dollar corporation with employees that have pensions, benefits, etc.
- Could set the bar too high for future Treasurers by requiring them to have a higher level of financial knowledge and skills.
- There could be unintended consequences that would threaten our tax status.
- Curious about whether other conferences utilize similar investment tools.
- Treasurer to do some research and come back with a report at the next meeting.

**Motion:** (Brought before the Council by the Financial Support Ad-Hoc Subcommittee) The Financial Support Ad-Hoc Subcommittee recommends that the Advisory Council create a Bylaws Chair as a standing position.

# Discussion:

• No discussion.

Simple majority required. 7 in favor / 0 opposed. Motion carries.

**Motion:** (Brought before the Council by the Financial Support Ad-Hoc Subcommittee) The Financial Support Ad-Hoc Subcommittee recommends that the Advisory Council adopt the

following policy regarding emergency Council meetings. This is proposed to be added to section 2.1 of the Council's Bylaws: "In the event that a motion needs to be considered by the Advisory Council outside of the regularly scheduled meetings due to the time sensitive nature of the motion, the Chairperson may call for an emergency meeting. The Chairperson shall be responsible for notifying each other member of Advisory individually. An emergency meeting must meet the minimum quorum requirement."

# Discussion:

- There may be times where Advisory needs to make financial decisions between the 3rd Quarterly meeting and the conference that would require a meeting. Not handled under current Bylaws about how to call an emergency meeting.
- Who determines what constitutes "an emergency"? Things move slowly in AA and often require ideas to be well considered in advance. Would this cause an unnecessary number of meetings to be called?
- Can we currently vote outside of the quarterly meetings?
  - Nothing that says that we can't.
  - Nothing that says that we can.
  - How would we decide to vote outside of a business meeting if we are not making that decision in a business meeting where we have received a quorum and a vote?

Simple majority required. 8 in favor / 2 opposed. Motion carries.

## **Minority Opinion:**

- What constitutes an emergency? There's nothing in there that says this. Could foresee this causing issues.
- This is further complicating something that doesn't need to be complicated. Worried about unintended consequences of changing the Bylaws without a clear need.

**Motion:** (Brought before the Council by the Financial Support Ad-Hoc Subcommittee) The Financial Support Ad-Hoc Subcommittee recommends that the Advisory Council adopt the following amendment to section 5.5 of the Council's Bylaws:

Current Section 5.5: "The Council shall endeavor to maintain a prudent reserve for the *conference support* if necessary. It is so designated that \$15,000 be maintained as a prudent reserve. The conference and reserved funds are arbitrary figures based on current economic conditions and can be altered by a simple majority vote.

Proposed Section 5.5: "The Council shall endeavor to maintain a prudent reserve for the *support of the conference by the Advisory Council and/or the Host Committee* if necessary. It is so designated that \$15,000 be maintained as a prudent reserve. The conference and reserved funds are arbitrary figures based on current economic conditions and can be altered by a simple majority vote."

# Discussion:

- What is the difference between the two? Is this necessary?
- Prudent reserve is not just to support the conference, but to support the Host Committee as well and the Advisory Council.

- Supporting the Host Committee should already fall under the umbrella of "supporting the conference".
- Every year, we have the Host Committee sign a Release of Liability form that separates us from them. This would potentially attach us to them. Could this cause a legal issue? We need to figure out who we are in relation to the Host Committee. Are we PENNSCYPAA? Are we an arm of the Host Committee? Are we a separate entity?
- The way that we got to such a large prudent reserve and the understanding (although not explicitly stated in the Bylaws) was for the purpose of the Advisory Council hosting PENNSCYPAA in the event of no viable Bid Committees. Since "conference support" was originally meant to host the conference, it is not clear that it could be used to support the Advisory Council or the Host Committee if a financial need was encountered. This would clarify the intention of the prudent reserve.
- The connection between the Advisory Council and the Host Committee is becoming closer and I'm not sure that that is a good idea.

Simple majority required. 3 in favor / 8 opposed. Motion fails.

**Motion:** (David H / Steve M) Contribute \$1,642.80 to service entities serving the Montgomery County area, sending 50% of that to the intergroup SEPIA and the other 50% split evenly between each of the Districts that serve Montgomery County.

# Discussion:

- Good idea to do splits with excess funds and to give to those areas where the funds came from.
- 7th Tradition states that we should not hold on to excess funds that have "no stated A.A. purpose". Prudent reserves cover between 3 and 12 months of expenses such as rent, supplies, services, outreach materials, etc.
- Are the Montgomery County Districts in need of money?
  - If the Districts don't need the money, they can continue to contribute it further down the chain to the Area or the General Service Board.
- If we wanted to have money set aside for a "stated A.A. purpose", we could establish an "operating fund" of about \$350 which would cover 100% of our current annual expenses.
- Outreach materials have not been purchased in a long time.
  - The prudent reserve could be used to purchase outreach materials and then be brought back to full reserves after the next conference.

Motion to Amend: (David H / Nora J) *Establish an operating fund in the amount of \$350.00 and* contribute *\$1,292.80* to service entities serving the Montgomery County area, sending 50% of that to the intergroup SEPIA and the other 50% split evenly between each of the Districts that serve Montgomery County. **Discussion:** 

- Should be higher in case we wanted to host events.
- Could be too close to the actual expenses.
- What do we currently spend?
  - \$350.00 based on:
    - Rent for 3 quarterly meetings at approximately \$50 each.

- Zoom Annual License at \$169.49.
- GoDaddy Annual Website Hosting at \$23.17.
- 12 months is usually maximum for reserve funds. Should be closer to 12 months since we don't have ongoing monthly income and receive large contributions once per year.
- Nothing wrong with dipping into the prudent reserve and being brought back up to full reserves by the next conference.
- Why isn't the \$1,000 seed money included in the operating fund?
  - Depends on how you look at the seed money. Since we give \$1,000 each year to the new committee and receive \$1,000 each year from the previous committee, it breaks even.
- Haven't had flyers printed in a very long time. How are we supposed to outreach without flyers? We should consider some amount for outreach purposes to be included.

Simple majority required. 9 in favor / 2 opposed. Motion carries.

# **Minority Opinion:**

• Should look further into the amount.

**Amended Motion:** Establish an operating fund in the amount of \$350.00 and contribute \$1,292.80 to service entities serving the Montgomery County area, sending 50% of that to the intergroup SEPIA and the other 50% split evenly between each of the Districts that serve Montgomery County.

# Discussion:

• Creating an operating fund would necessitate a change to the Bylaws which would require a 30 days notice to the Council.

**Motion to Amend:** (David H / Steve M) **Establish an operating fund in the amount of \$350.00 and** contribute \$1,292.80 to service entities serving the Montgomery County area, sending 50% of that to the intergroup SEPIA and the other 50% split evenly between each of the Districts that serve Montgomery County. **Discussion:** 

• No discussion.

Simple majority required.

9 in favor / 1 opposed. Motion carries.

**Amended Motion:** Contribute \$1,292.80 to service entities serving the Montgomery County area, sending 50% of that to the intergroup SEPIA and the other 50% split evenly between each of the Districts that serve Montgomery County.

# Discussion:

• No discussion.

Simple majority required. 11 in favor / 1 opposed. Motion carries.

# **Minority Opinion:**

• Not opposed to contributing, but we should better consider the amount of expenses that we need.

Motion to Reconsider (Nora J / Brian A)

Simple majority required. 3 in favor / 6 opposed. Motion fails.

# Election for the position of Pittsburgh Liaison: Aaron M standing

Substantial unanimity required. 12 in favor / 0 opposed. Motion carries.

# New Business (Postponed until the next meeting)

- Should the Advisory Council purchase an SSL Certificate for the website at the cost of \$84 per year in order to remove the unsecured website notification that visitors may encounter.
- Vote on the continued membership of Steph S as a member of the Advisory Council due to 2 absences in one year as per the Bylaws.
