In summary, the LTTO's total investment portfolio outperforms its benchmark (Bank of America Merrill Lynch 1-10 Year Treasury & Agency Index) with 32.43% higher returns. Total FY23 interest distributions to member districts will be approximately \$6.4 million.

Cook County Property Tax Collection Delay - FY24

The Board discussed the likelihood of a 60-day delay in the collection/distribution of the 2022 second installment of Cook County property taxes. The delay could adversely affect a couple of member districts. Additionally, the Board discussed again offering financial support to member districts in the Fall via short-term lending or warrant purchases. This financial assistance program keeps tax dollars as close to the tax base as possible and reduces the overall borrowing expenses associated with our member districts.
