#### **Board Update**

THE

Happy Fall! We are so thrilled to have finally experienced some rain - hopefully the grass is getting greener, and the trees are perking back up! The fall is a great time for garden clean up or to start your fall garden. Spring perennials can be planted now, and it is time to remove dead leaves, stems and spent flowers from your existing perennials.

Fall also brings the time of the year when the Board works on the budget for next year. We plan to provide updates at the Annual Meeting with any potential major changes. The drought has led to a lot of leaks around the neighborhood, most of which have been repaired. There was also a leak that many of you noticed at the clubhouse, this has since been repaired. There is a new Flag and Sign policy (see the new policy for details) that will hopefully clarify questions on flags and signs allowed in the neighborhood. We have also been working diligently on the Green Space Revitalization Project (see the Green Space update for more details). Many of you will be happy to hear that we renewed our contract with the Constables and are still active in the Security Co-op. The Co-op consists of 11 neighborhoods nearby, who employ 11 constables to patrol between these areas - this ensures that we are covered 24/7.

#### Flag and Sign Policy

Country Village HOA has developed a new Flag and Sign Policy effective immediately.

Background: The deed restrictions for flags and signs were historically very narrow in what was allowed. According to the deed restrictions, sports or school signs were technically not allowed. Therefore, this part of the deed restrictions was not enforced or sometimes only partly enforced creating inconsistencies.

#### Flag and Sign Policy (cont.)

New Policy: Policies can be made to clarify deed restrictions.

#### THE NEW POLICY ALLOWS:

- · Seasonal spirit, school, sport, other official country flags, or college flags.
- Only US and Texas flags, which must be flown according to Federal or State flag laws.
- Home security signs.
- Political signs fall under the state code they are allowed 90 days before an election and must be taken down no later than 10 days after an election.

#### NOT ALLOWED:

- Unofficial/modified Texas or US flags
- US or state flags hung in ways that are not up to federal or state code.
- Political signs outside of the 100-day window around an election.
- · Signs with offensive material or profanity.
- Signs other than the ones stipulated above (apart from for sale or lease signs).

#### **Green Space Revitalization Update**

We have been diligently moving along on the Green Space Revitalization project! Updates to the project are as follows:

- Our Landscape Designer, M2L, has completed the official survey of the area and have determined additional recommendations. Even with the "credits" for removing the two tennis courts, we will still need more retention area than originally expected. This area will remain green space and only hold water temporarily until it has drained. This will ensure we do not experience flooding risk to the area.
- The contract with Trans Texas to complete the overlay refinish of the two tennis courts and demo the front two courts has been finalized! Their projected start date is in January 2024.
- We have had discussions with the pavilion provider and are continuing to work on their contract.
- We have submitted the documentation for the loan to fund the project up front, and plan to finalize soon!

# A Holiday Indulgence From Our Home to Yours

#### Jam Thumbprint Cookies

3 sticks unsalted butter 1 cup sugar 1 tsp pure vanilla extract 3 1/2 cups all-purpose flour

1/4 tsp kosher salt1 egg beaten with 1 tbsp water7 oz sweetened flaked coconutRaspberry and/or apricot jam

Preheat oven to 350 degrees. In an electric mixer, cream together butter and sugar and then add in vanilla. Separately, sift together flour and salt. At low speed, add flour mix to creamed butter and sugar. Place on floured board and roll flat. Wrap in plastic and chill for 30 minutes. Roll dough into 1 1/4 inch balls. Dip each ball in egg wash then roll in coconut. Place on ungreased cookie sheet and press a light indentation into top of each ball with finger. Drop 1/4 tsp of jam into each. Bake for 20 to 25 minutes. Enjoy once cool!


