- B. Update on improvement projects for 2020

- C. Other landscaping issues

 There was no further discussion, motion passed with all in favor.
 - ii. \$7,425 John Peart present a weathermatic smartlink service renewls in installment payments Joe Lighttowler made the motion to approve the expense. Larry Orlov seconded the motion. There was no further discussion, motion passed with all favor.
- D. Landscape Oversight Advisory Committee
 Bruce Litchfield announced the landscaping advisory committee members and discussed the function
 of the committee so far and provided an email update.
- E. Irrigation Evaluation

Brightview presented the cost savings for the irrigation in gallons with installation of the smart controllers. Larry Orlov further presented the cost saving plan with reduction of the service contract and xeriscaping of non-essential grass areas.
