#### ection 3: HAZARDS IDENTIFICATION

### 4ERGENCY OVERVIEW

DANGER. Extremely flammable. Contents under pressure. Harmful or fatal if swallowed. Aspiration hazard if swallowed. Vapor harmful. Keep away from heat and flame. Can cause nervous system depression.

Primary Route of Entry: Skin contact, inhalation

Acute/Potential Health Effects:

#### ection 4: FIRST AID MEASURES
