From The Board:

The City of Sugar Land has begun an inspection of the trees along street rights-ofway in Sugar Mill for compliance with City Ordinance. The ordinance states: *Where the tree overhangs a residential street, there must be a clear space under the tree that is 12 feet above the street surface and 8 feet above the sidewalk surface.* In the event you receive a notification from the City there is a thirty day time period to get the trees trimmed.



The BOD would like to advise all residents that the deed restrictions require all trees and bushes on their property to be properly trimmed. The most important trees and bushes are the ones

planted within 10 feet of community fences. Large trees and bushes can do much damage to our property, and it is important that residents tend to the plantings in their backyards. We have asked our property manager to be mindful of these harmful plantings, and the ACC will support the mailing of letters to enforce this trimming mandate.

Traditionally Valentine's Day is the time when Texans trim their roses. It looks like the weather this year will push that trim date a bit later in the month. Yard clipping/cutting trash pick up day is Monday. Please remember that your refuse is to be taken to the curb no earlier than 7PM.

Spring is a good time to pressure wash any mildew off of your home, make sure window screens are not torn and that trees are trimmed. Flowering bushes like azaleas should not be trimmed until after the blooms are spent. It is also a wonderful time to make sure that there are no holes big enough for squirrels to enter the attic as they can do much damage to the electrical wires of the home. A reminder too from Texas Parks and Wildlife that we share lands with wild animals. It is bobcat mating season and there have been bobcat sightings in Sugar Land. If you see an animal that belongs in the wild, be it a bobcat or coyote, please call Sugar Land Animal Control at 281-275-2842. An animal control officer will be dispatched and the animal tranquilized and relocated to a natural environment for that animal. There is such beauty in these wild creatures and we are lucky to have a reminder of the coastal prairie where we are fortunate to live. There are red-tailed hawks and owls living in our community too – such splendor in the skies.

In our next newsletter there will be a list of five cul-de-sacs that have been updated with bull rocks instead of shrubs. The Board is progressing on renovations to our community that reduce the need for water while freshening the look. There will be more updates as the work progresses.

The new bulkhead on Ragus Lakes Drive is being installed (see details on page 3). The December time was preempted by the City's drainage work on that street. A new deck area will be installed after the bulkhead settles. We have locked the gate leading to the deck/bulkhead until all the work is complete. It is a safety imperative. Please do not enter this area until all work is complete.

Lastly, we have included the ACC form in this edition (page 2). Please remember that before making any changes to the exterior of your home, please submit a request to the ACC for approval. This includes paint (even if it's the same color), roofing, additions, fencing and play equipment, or any other work/changes being done to the exterior of your home.

Newer isn't always better...

This is one of my favorite times of the year. Why? Well, this is the time of the year that all of the major tackle manufacturers introduce all of their new products for the upcoming spring fishing season. This is when they showcase all of the latest and greatest rods, reels, lures, lines, and accessories that they hope you will add to your "must have" list. And believe me, I have added many items to my list over the years.

But are these new products necessarily better than what we have used over the years? Do we catch more fish by using the newest rods, reels, and lures on the market? I think that subject is open for debate. Sure, I try to keep up with all the latest developments and trends in fishing tackle, and I invest in something new when I think it might benefit my style of fishing. But many times, I revert back to my "tried and true" tackle that has served me well over the years. Truthfully, my favorite rods that I rely on were purchased seven or eight years ago. And no, they are not as lightweight as the new "nanotech" rods of today, but they are strong, sensitive, and reliable. What more do I need? And when it comes to reels, most of my favorites have been out of production for 15 years or more. But I still use them on every fishing trip and they perform flawlessly. Sugar Mill Drainage Project To Begin Soon

Sugar Land City Council recently approved a \$1.1 million contract with Metro City Construction, L.P. for drainage improvements in Sugar Mill.

The improvements are identified in the City's master drainage plan and will reduce the risk of street ponding and flooding previously reported in sections one, two and three of Sugar Mill, an area surrounded by Eldridge Road, Lakeview Drive, Wood Street and Greenbelt Drive.

The project builds on drainage work that was completed in 2011. Since then, the City focused on acquiring easements and a permit from the U.S. Army Corps of Engineers. Construction will soon begin on two storm sewers along Rolling Mill and Hillary Circle that will deliver water to Cleveland Lake. The project is expected to last about six months.

Drainage improvements continue north of Sugar Mill in the Ragus Lakes area. The yearlong \$4.4 million project began last November and will be completed in phases.


The Ragus Lakes project includes installation of box culverts along Ragus Lake Drive, Vickery Drive, Kathi Lynn Lane, Jo Ann Lane and Baytree Drive and a drainage pipe along Jo Ann Drive between Vinehill and Mary Sue Court. The planned improvements continue into Covington Woods along Vinehill Drive to Baytree and Maygrove.



Revised Agreement To Imperial Development

Sugar Land City Council recently amended an agreement between the City and Cherokee Sugar Land LLP for the Imperial Redevelopment project, a 700-acre masterplanned community located at the northeast corner of State Highway 6 and U.S. Highway 90A. The amendment provides development applications to modify plans for the overall project, maintains the mix of uses originally planned for the redevelopment of the refinery and establishes time lines for developer obligations for public improvements at the refinery site. Key points of the amended agreement include the following items: The development manager may submit concurrent applications to modify the general plan and planned development zoning district. The modifications will include a change in land use. Area previously designated for a business park and commercial development along Oyster Creek will be considered for single-family residential. The amendment sets minimal taxable values per acre. Designated commercial areas along Highway 6 may change to office and business uses. The development manager will construct infrastructure necessary to support initial redevelopment of the Imperial Sugar refinery site within two years. The development manager will remodel or construct shell space for a historic museum within two and a half years. For more information visit www.sugarlandtx.gov.

MARTHA'S TIPS AND TRENDS TO HELP MAXIMIZE HOME BUYING AND SELLING

FIRE FIGHT: Tangled extension cords? Power strips galore? Your home's wiring

system might be working overtime with all the new gadgets you received for Christmas - and it might be at risk for igniting a fire. Straighten out these wiring prob-lems and more with tips from This Old House. Have a licensed electrician walk through your home every five years to look at the wire insulation and the service panel and check for any code violations. If you're doing it yourself, start by turning off the circuit at the main breaker panel. Code requires outlets within 4 feet of a door and every 12 feet after that. Ex-

tension cords can be useful, but keep in mind that smaller-gauged cords can overheat and start a fire if overused. Adding more outlets can run about \$100 per outlet on first levels and \$200 upstairs. Another fire hazard is overlamping, in which light fixtures have a bulb with higher-than-recommended wattage installed. Check the fixtures' wattage limit or use bulbs that are smaller than 60 watts. Flickering lights aren't just annoying —they could be a sign of wire trouble, too. The outdoor fitting where overhead cables from the power line come into the house, or frayed wiring in the weatherhead, causes the short when the cable moves.
