AAG Honors Longtime Director

Deb Hawkes, South Amana, has been named the Amana Arts Guilds' Friend of the Arts, for her service as executive director of the Amana Arts Guild for more than 10 years. Hawkes retired this past spring.

Each year the Amana Arts Guild honors one person at its Festival of the Arts with this award given in recognition of their contributions to the arts and culture of the Amana Colonies, keeping Amana folk craft traditions alive and promoting creative work here in the community.

President Kristie Yoder made the presentation at the AAG Festival August 13 in Amana. Erin Shoup, director of the AAG, shared this, "This year we proudly presented this award to Deborah Hawkes of South Amana. Deb served as the Executive Director of the arts guild for over 10 years and helped create a strong and financially stable organization. Her calm demeanor and ready smile have allowed the Guild to grow our class offerings, increase the scope of the Festival of the Arts, expand our gallery space, and remain a constant presence through our community in preserving Amana folk arts and crafts. Deb has always been a friend to those who stopped in at her High Amana office, and we are ever more thankful that she continues to be a participating artist in our gallery. Deb is a rug weaver, as well as a knitter, and her colorful chickens are a big seller at the Gallery on Main. The Guild wishes to thank Deb for her many years of service and we are honored to have presented the Amana Arts Guild Friend of the Arts award to her."

Deb was responsible for the planning and implementation of many major projects during her time at the AAG and made sure the guild's major annual events such as the Founders Day Dinner, the Festival of Arts, the summer art and Art Iowa workshops happened.

"She has been a godsend to the AAG. We are so grateful for all that she has done for the guild and for the community," Yoder shared.

The 45th annual festival, held August 13 in Amana, was a big hit with strong attendance and great art exhibited. Shoup noted, "We had an excellent turnout thanks to good weather, good food, good music and most importantly, great art. Thanks to all of our artists! The artists we've spoke to since the festival have expressed very positive feedback about this year's turnout and sales." She added that this year the food was provided by Smiley's Soups and Sandwiches, Stone Wall Brick Oven Pizza and the Rusty Tractor. Scott Engledow, S and P and John Kostle were the musical performers. The day brought lots of visitors who took in the art while the kids enjoyed the hands-on rug weaving with Linda Grambau, the chalk-a-walk area and bubbles fun.


