I wish to open this months report with a request to all members to submit to their Local officers "the wish list" for the upcoming round of bargaining. The Section Six notices will be prepared and served on or after November 1, 2009 on the following properties under the jurisdiction of this office:

The resolution hearing for the FMLA dispute was recently conducted and as soon as the decision is rendered, it will be posted on the Council web site. Another issue, the Department of Transportation Direct Observation requirement for return to duty and follow-up drug testing remains in the courts. When the decision is rendered, that decision will also be posted on the Council web site.

Our Business - Representation & Service

First Quarter Report May 1, 2009 Page Two

We have seen reduction of forces on the BNSF, CN and CP properties the past quarter with rumors circulating of more to come. Aqain, I would like to request that if your Local is advised of force reduction that will effect this Organization, first and foremost, provide the member with any information necessary and comply with the requirements of the controlling Agreement. Most all Agreements require that the furloughed employee keep the Carrier and Local apprised of a correct mailing address. The Local Financial Secretary should be notified of the furlough for completion of all required paperwork. Please do not hesitate to contact this office with any questions.

This past quarter, in connection with representatives of various District officers, officer training has been conducted for the following Locals 533, 757, 794.

This quarter the Council staff has conducted business or obtained information relative to the following Carriers affecting Local members as follows:

#### Canadian National/IC-CCP-WC-DMIR-DWP

Force reductions were announced on the DM&I property at the Duluth and Two Harbors Docks. There may be an opportunity for those who were notified of the furlough to perform other work on the property that would have been performed by contractors. There is no final decision at this time to report.

At least three (3) Public Law Board decisions rendered; two (2) rules issues and one (1) discipline issue. The Claimants and Locals have been notified of the decisions rendered.

The CN's acquisition of the EJ&E is outstanding with a trigger date of implementation of the Agreements on May 1, 2009. We have many issues outstanding which will be addressed over the next several weeks.

We are making considerable progress in the updating of the IC Telecommunication Department Agreement.

The compensation issue on the DWP has not been raised again by the Carrier.

#### Canadian Pacific/Soo

The Carrier has reduced Mechanical Department forces at the St. Paul Shop effecting several of our members.

We have been advised by the Carrier that the Gainsharing payouts for 2008 have been calculated and presumably as of this writing have been paid. Most of the departmental goals for 2009 have been determined and forwarded by this office to the Local members, with Mechanical and St. Paul B&B Electricians outstanding.

We had hoped to begin on the updating of the Mechanical Department Agreement this quarter; however, due to the unexpected death of Chicago Service Manager Jim Johnson, this project is on hold.

### Gary Railroad

The Gary Railroad was formed with the remaining EJE property that was not a part of the CN's Acquisition of the EJ&E. The employees represented by this office were assigned to the property as outlined in the Implementing Agreement negotiated by this office. As of this writing, there have been several questions presented and answered; however, we are not aware of any issues outstanding.

### Belt Railway of Chicago

This office reached agreement for the establishment of a Maintenance Electrician position on the property. As of this writing, there have not been any issues with this position.

We are awaiting the appointment of a new Labor Relations officer on the property to start with the updating of the Labor Agreement.

#### Northern Indiana Commuter Transportation District

Assistant General Chairman Mark Klecka, in conjunction with the Sixth District office, is working with an area Local to establish a training program for our members on this property.

#### BNSF Railway Company

BNSF Mechanical Department is going through what may be termed a "metamorphosis" from the retirement of Vice Presidents, CMO's and change in Shop Managers, to reduction of forces, each day is a new issue.

First Quarter Report May 1, 2009 Page Five

In late February, BNSF announced a reduction of approximately one hundred forty (140) Mechanical Department employees, fifteen (15) of the one hundred forty (140) represented by this Organization. We continually hear rumors that more reductions are to come as locomotives go into storage. We have also been notified of a few Engineering Department Electrician positions being cut at certain locations; however, with vacancies at other locations, we are not aware of anyone being furloughed.

There have been some concerns expressed about the Carrier's change in administrators of the Corporate Lodging Policy and hotels under that policy. If anyone encounters a hotel with issues, please report those issues to this office.

With the recent fatalities, we are hearing that there are a large number of FRA inspectors on the property and Carrier Managers performing work place observations which are resulting in discipline issues. I urge your compliance with the Carrier's Safety Rules, particularly Blue Flag Rules.

There have also been a number of issues in the Telecommunication Department with vehicle incidents resulting in discipline issues for our members.

Two (2) cases were argued at the NRAB offices in March with the decisions rendered and the Claimants notified.

Attached, please find the first quarter travel, vacation and financial reports, as well as one (1) article of interest. There is a large amount of news regularly posted on our web site that is of an interest to our members.

### SECOND QUARTER REPORT, 2009 SYSTEM COUNCIL NO 16 OF THE INTERNATIONAL BROTHERHOOD OF ELECTRICAL WORKERS

Brothers and Sisters:

This past quarter there have been two (2) significant decisions rendered that will affect the railroad industry and our members.

The challenge of the DOT Direct Observation Drug Testing by the Carriers and several Organizations was not successful. The court recently lifted the stay, the final rule is being prepared and enforcement will be forthcoming. As I understand the rule, anyone returning to duty following a Rule G and follow-up testing will be subjected to direct observation when presenting a sample.

The second issue is the FMLA dispute. The Arbitrators not only upheld the position of the employees, the remedy phase was also successful. Every employee who presented a valid claim will receive a day of pay for each day of vacation and/or personal leave he or she was required to use for FMLA purposes.

Complete details are currently posted on the Council web site for both issues discussed above.

The force reduction announced on the DM&I property has been delayed as the employees were able to perform electrical work on the property in lieu of a contractor.

We are still working on a few outstanding issues relative to the CN/EJE transaction.

We are very close on completion of the updating of the IC Telecommunication Department Agreement with another meeting scheduled in mid-August.

### Canadian Pacific/Soo

The Carrier has recalled at least three (3) Electricians to service at the St. Paul Locomotive Shop.

There are currently issues with the Fiber Optic Agreement that are being investigated by the Local officers.

#### BNSF Railway Company

On the Tuesday after Memorial Day, we were advised that there was going to be approximately forty (40) Electricians furloughed in the Mechanical Department across the property.

The BNSF Mechanical Management officers announced a new safety initiative this month. Details have been forwarded to Locals involved in a separate mailing.

We continue to hear of a few issues with the Corporate Lodging Policy. If you find a hotel in the program that has issues, please report in writing to this office.

This office is currently discussing the Carrier's application of ETMS equipment with Telecom management.

We are currently investigating Mechanical Department work at Birmingham, Alabama. Apparently, the Company is performing locomotive inspections, work that should involve our members.

There have been a number of cases arbitrated and decisions rendered. The Locals and Claimants either have been or will be notified of the decisions shortly.

This office is currently involved with two (2) separate seniority issues on this property, which are quite serious and should have been addressed long ago.

Each year the Carrier's post the seniority rosters. The Agreements govern and allow for a period for correction if errors are found. Each year there is a reminder to this fact set forth in this report. Resolutions of these disputes are not predictable at this time since time limits may be an issue here. Again, it is the responsibility of both the Local, as well as the individual member, to review the rosters when posted and notify the Carrier in writing, as outlined in the controlling Agreement, with respect to any errors that need to be corrected. Please provide a copy of that correspondence to this office for our files.

As I have discussed in a number of previous reports, disciplinary hearings continue to be conducted over blue flag and vehicle incidents. These two (2) issues are serious. Blue flags are for the protection of the employees and when the cases are arbitrated, the Neutrals seem to side with the assessment of disciple when there is a violation of the rule. Again, please be extremely careful when operating a Company vehicle and please be very diligent and comply with the Company's Blue Flag Policy.

### THIRD QUARTER REPORT, 2009 SYSTEM COUNCIL NO 16 OF THE INTERNATIONAL BROTHERHOOD OF ELECTRICAL WORKERS

Brothers and Sisters:

In the previous two (2) quarterly reports, the Locals were requested to provide input for their Section Six proposals. Those proposals were submitted to the Railroad Department and earlier this month, the System Council General Chairmen and Director of the Railroad Department met to formulate the notices. The Health and Welfare will be formulated in connection with the Cooperating Rail labor Organization (CRLO) and we may also serve on individual Carriers for specific Local issues.

President Hill is looking for the railroads involvement and our Local Unions in the Code of Excellence program. I have attached an overview of the "Code of Excellence" program. This particular draft was for use in the utility industry and is being formatted for the rail industry. If any Local has an interest in moving forward with this program, please advise.

We continue to hear from various locations that Carrier traffic is slow and there are rumors of further force reductions. As of this writing, the Carriers have not provided any indication of further force reductions.

On July 13<sup>th</sup>, 14<sup>th</sup>, and 15<sup>th</sup>, the annual Rail Department meeting was held in Chicago. I urge all Locals to attend this meeting for a chance to address issues with the Railroad Department, insurance providers, the Railroad Retirement Board and others.

On September 24<sup>th</sup> and 25<sup>th</sup>, 2009, Vice General Chairman Heyland and the undersigned attended the annual National Association of Railroad Referees (NARR) meeting in Chicago, Illinois. The meeting provides all attendees with valuable and up to date information on railroad arbitration issues.

This office has for some time sent letters to the Local Presidents and Financial Secretaries when the per capita reporting is submitted and errors are found. I would like your input as to whether or not this action is beneficial or worthwhile.

This past quarter, in connection with representatives of the Sixth District, officer training has been conducted for the following Locals: 1475.

We have been working with Local representatives on the DM&I on an agreement for an updated "Mechanic in Charge" (MIC) classification at the Duluth and Two Harbors Docks.

There are currently two (2) positions open on the Escanaba Ore Docks for Electricians. If anyone is interested, please contact this office for further information.

I wish to take this opportunity to extend my appreciation and sincere thanks to Woodcrest Shop Committeeman Mike Ciger who recently resigned the position. I have worked with Brother Ciger since the amalgamation of system Council 10 into this office.

The Woodcrest Mechanical and IC Telecommunication rosters, as amended, as a result of the EJ&E acquisition were posted for several weeks and no exceptions presented to this office. The Carrier was notified to post the 2010 rosters accordingly. The Locals have been provided a copy of all correspondence concerning this matter.

### Canadian Pacific/Soo

As of this writing, all of the furloughed Electricians and/or Apprentices at the St. Paul Shop have been recalled to service.

We are currently investigating, as are other Organizations, an issue with what the Carrier is calling "Regulatory Blood Testing". Counsel has been contacted.

A claims conference was conducted on September 17, 2009. Claimants and Locals were provided updates on the status of outstanding issues.

Information has been conveyed to the undersigned that the issues with the Fiber Optic Agreement have been addressed and resolved.

The officers and staff of System Council 16 wish you the best for a prosperous and happy new year.

National Section Six notices have been served on the Carrier's in National handling. The first negotiating session is scheduled in Washington on January 19, 2010. The Carrier's under the jurisdiction of this office in National handling include Belt Railway Company of Chicago, BNSF Railway, Canadian Pacific DBA Soo Line Railroad Company and the Gary Railroad.

Reports are mixed concerning rail traffic. We have just been advised of a reduction of force on Montana Rail Link and we have been advised that the CN is hiring Locomotive Electricians at various locations. A copy of the CN job bulletins is posted on the Council web site.

Most Agreements, if not all Agreements, under the jurisdiction of this office require the posting of seniority rosters in the month of January. I ask that all members and officers check the rosters for accuracy and if errors are found, please get them corrected or provide all necessary information to this office for investigation.

In the third quarter report, I advised that IBEW President Hill is looking for the railroads involvement, as well as our Local Union involvement in the Code of Excellence Program. If any Local is interested in moving forward in this program, please advise.

Enclosed with this report are two (2) documents containing information that is very important to Local Union representatives and railroad employees. They are:

- 1. A copy of information from our counsel of Zwerdling, Paul, Kahn and Wolly. The issue involves a Carrier's right to discipline an employee for conduct he engaged in while acting as a Union representative. A copy of the Court decision is also attached to this document.
- 2. A document prepared by the FELA firm of Hoey and Farina concerning the use of mediums and devices that affect your employment with a railroad and an FELA claim.

This past quarter, in connection with representatives of the Seventh District, officer training was conducted for Local 1199.

This past quarter the Council staff has conducted business or obtained information relative to the following Carrier's affecting Local members as follows:

### Belt Railway Company of Chicago

Two (2) employees of the Carrier recently were granted a craft transfer to become Locomotive Electricians in the Mechanical Department that resulted in an issue with the establishment of seniority as they were both transferred on the same date. A Letter of Understanding was drafted to address this and future issues of this nature. The letter is currently being progressed.

#### Canadian National IC - CCP - WC- DMIR- DWP - EJE

As of this writing we are preparing our Section Six notices collectively with System Councils 7 and 9, who also have jurisdiction on other CN properties. We have just received the final requests from our members to be placed on the notices. A copy of the notices will be provided to the Locals when served.

There are currently openings for Locomotive Electricians at Fond du Lac, Wisconsin and Waterloo, Iowa. It is my understanding that an Electrician was recently hired at the Escanaba Docks and a Locomotive Electrician is in the process of being hired at Proctor, Minnesota.

We continue working to obtain an Agreement on the DM&I property for an updated Mechanic in Charge Classification at the Duluth and Two Harbors Docks.

We continue to work toward finalization of the updating of the IC Communication Department Agreement.

### Canadian Pacific/Soo

Reported in the third quarter report was an issue with "Regulatory Blood Testing". Several Organizations, including this office have collectively retained counsel to address this issue for our members.

We are currently investigating a problem with the rate of pay of one of our members.

The undersigned is scheduled to meet with the St. Paul Shop Manager and Local Chairman on January 21, 2010 to discuss outstanding issues as our December meeting was cancelled by the Carrier representative.

We are currently discussing an issue with Apprentice training on the property.

The subcontracting issue at Livingston discussed in the third quarter report has been resolved on a Local level.

#### BNSF Railway Company

The Memphis Intermodal issue has been resolved. We were able to obtain an additional System Electrician for maintenance duties at the facility. I would like to thank our members at Memphis for their assistance in resolving this issue. We still have a number of issues we are working to resolve that were reviewed in the third quarter report.

We continue to handle or assist the Locals in a number of discipline issues. I again urge all members to comply with Carrier rules as we are seeing strict enforcement of rules on the entire property.

In late December we settled all but four (4) rules cases that were outstanding on the property, some of the cases going back a number of years. The settlement rendered payment to our furloughed members and some active members. As time permits, those employees will be notified of the settlement.
