# Reporting Requirements

#### Your checklist to "Good Standing" with the Regional Water Quality Control Board

It has yet to be determined which parcels fall within the high susceptibility status. Of note, members who responded 'yes' to question A3 in the Farm Evaluation will likely need to complete a certified SECP as well. Once the list is finalized STWEC will notify these select members and provide information on how to meet the requirement. The SECP template and instructions are posted on the STWEC website; see Member Requirements tab. A self -certification training program is being developed similar to the NMP self-certification. The certified SECP is to be kept on farm or primary place of business and updated as conditions change.

## Message from the President

Well, another year has passed and the water quality in the Sacramento Valley, both surface and ground, continue to show little if any contamination from agricultural activities.

As you see, your bill has again increased in spite of this coalition's intention to keep the fees as low as possible while insuring that you are covered under the Irrigated Lands Regulatory Program (ILRP). There are two reasons for the increase. First, we have lost members and acreage, particularly in the past two years. A majority of STWEC members own small agricultural properties between 1 and 20 acres. As fees and regulations have increased, a number of the small irrigators have decided to stop farming commercially. It is estimated that there are still 1,000 irrigators with substantial property that should be enrolled. This could significantly lower the fees for everyone. The Regional Water Board has advised all those irrigators by letter that they should be enrolled. However, due to minimal enforcement staffing, the Water Board is unable to make physical inspections of those properties and file civil penalties against those irrigators. Second, the Regional and State Boards continue to add additional requirements. This year will

be the Soil and Erosion Control plans. This costs staff time to insure that all members are in compliance.

During the past year the Water Board has brought some significant civil fines to some of the persons/companies that should have enrolled early on. As agricultural irrigators, we do not like to see anyone on the receiving end of those fines. However, all of you have participated as required. Those that have chosen to wait have financially cost all of us.

We look forward to some positive changes to the program in 2017. We anticipate that the Water Board will deal with the water quality issues of E. coli and dissolved oxygen by recognizing that the agricultural community is not responsible.

### NMP Certification Options:

The Order requires members with parcels within a groundwater High Vulnerability Area (HVA) to prepare and implement a certified Nitrogen Management Plan (NMP) in one of the ways provided below

- Self-certified by the member member attendance at a training program for NMP certification. Workshop dates TBD and will be posted on the STWEC website.
- Self-certified by the member whose NMP plan adheres to a site-specific recommendation from the NRCS or UCCE.
- Certified by a nitrogen management specialist (i.e., Professional Soil Scientist, Professional Agronomists, Crop Advisors certified by the American Society of Agronomy, or Technical Service Providers certified in nutrient management in California by the NRCS).
- Certified in an alternative manner approved by the Regional Board's Executive Officer. Such approval will be provided based on the Executive Officer's determination that the alternative method for preparing the NMP meets the objectives and requirements of this Order.
