# MAIL CALL

The **Marine Corps League** is the only congressionally chartered United States Marine Corps-related veteran's organization in the United States. Its Congressional Charter was approved by the 75th U.S. Congress and signed by President Franklin D. Roosevelt on August 4, 1937. The organization credits its founding — in 1923 — to legendary Marine Corps Commandant John A. Lejeune. The group holds a congressional charter under Title 36 of the United States Code.

#### Marine Corps League Mission Statement:

Members of the Marine Corps League join together in camaraderie and fellowship for the purpose of preserving the traditions and promoting the interests of the United States Marine Corps, banding together those who are now serving in the United States Marine Corps and those who have been honorably discharged from that service that they may effectively promote the ideals of American freedom and democracy, voluntarily aiding and rendering assistance to all Marines and former Marines and to their widows and orphans; and to perpetuate the history of the United States Marine Corps and by fitting acts to observe the anniversaries of historical occasions of particular interest to Marines.

By-law Draft #2 VIII was discussed at the January meeting. It has been updated with new language to reflect "if there are no members running for these positions". Since there has been a change, it, too, will need to be held over for a vote at the March meeting.
