## 2025

Successful operation of this campground depends upon your compliance with these rules.

- 1. Refrain from loud noises and outside activities during the "quiet time" hours of 10 PM to 6 AM. At NO time should outdoor music/TV be at a level that others hear it in their campsites.
- 2. No disruptive noise or offensive behavior is allowed.
- 3. The use of fireworks (including firecrackers and sparklers), firearms and other potentially lethal devices is prohibited in the campground and at the boat ramp.
- 4. Alcohol will be permitted only at campsites. Refrain from drunkenness and intoxication while camping.
- 5. Golf carts and similar type motorized off road vehicles and carts will not be permitted. (Exceptions made only for persons with medical documentation stating they are not mobile without the use of a cart. Manager approval required.) If approved, **no** 'CRUISING" AND THE APPROVED PERSON MUST BY ON THE CART WHEN IN USE.
- 6. A 20 MPH speed limit must be observed at all times. No "cruising around".
- 7. Children must be supervised by an adult at all times.
- 8. Bicycle, skateboard, or scooter riding is prohibited from dusk to dawn.
- 9. The registered camper is responsible for the conduct of his/her visitors.
- 10. A maximum of three vehicles may park at each campsite.
- 11. Only the camping unit registered will be allowed on the campsite. "Leasing out" the campsite/camping unit is prohibited.
- 12. Refrigerators and freezers must be kept inside the camping unit.
- 13. No dumping of waste or "gray" water on the ground is allowed.
- 14. All trash must be bagged and disposed of in dumpsters. DO NOT place items around the dumpsters.
- 15. Do not place nails or screws in the trees.
- 16. No swings are allowed to be hung from the trees.
- 17. The shoreline throughout the campground may be used by all campers for swimming, fishing, tying up boats and anchoring personal watercrafts.
- 19. Camping is at your own risk. Chatuge Woods Campground is not responsible for illness, injury or personal property damage.
- 20. Campground management reserves the right to revoke your camping privileges should management determine it to be necessary. You may be requested to leave the campground and be given a date and time to have the camping unit, camping equipment and personal property removed. Failure to comply may result in the camping unit being towed at the owner's expense. A refund will **not** be given if camping privileges are revoked.
- 21. Do not remove picnic tables from any campsite.
- 22. Do not alter or make improvements to campsites.
- 23. Under no circumstances shall pets be left unattended at campsites.
- 24. Persons bringing pets are responsible for proper removal and disposal of any waste produced by the pets in a timely manner. Do not bring animals that are aggressive toward people/ other animals or that bark frequently/loudly disrupting the camping enjoyment of others.
- 25. Under no circumstances should more than two pets be kept per occupied site.
- 26. Pets must be kept on a leash or a controlled wireless area of the camping unit. (short leash in common areas)
- 27. Pets are prohibited in bath houses.
- 28. Refunds require a 30 day notice.
- 29. Chatuge Woods Campground reserves the right to change or add to any rule without notice.
- 30. We ask that when your camping unit is not in use the a/c be turned off or set at a warmer temperature.

- 31. Do not plant gardens.
- 32. Do not tape, staple, nail or tack anything to picnic tables that is not easily removable.
- 33. Do not place docks or decks in the water. Remove any items you placed in the lake at the end of each camping season.
- 34. Roofs shall not be constructed over camping units.
- 35. Camping units will remain truly mobile without any permanent connections, foundations, porches or similar type structures.
- 36. Satellite dishes must be portable and removed at the end of each season unless affixed to the camping unit in a manner that is ready for road travel.
- 37. Clear all items from campsites at the end of each season. The only items to be left are those belonging to the campground. ONLY picnic tables that belong to the campground, fire rings that belong to the campground (all personal fire rings are to be removed), and firewood that belongs to the campground (all personal firewood must be removed.) Do not cover these items with a personal tarp or plastic as those items will be disposed of.
- 38. Items left at the campsite after November 1 will be considered abandoned and disposed of at the expense of the registered camper. This includes items left on the shoreline and lake bed. For example... wet, muddy carpet that requires the use of heavy equipment and a dump truck to be removed. There will be costs charged to the registered camper for this campground expense. Failure to clear sites may result in a CENCELLATION OF RESERVATIONS FOR CAMPING IN THE FUTURE.
- 39. Do not advertise or insinuate that a campsite is included with the sale of a camping unit. If the registered camper no longer wishes to use the campsite, a refund may be requested and the next person on our waiting list will be given opportunity to obtain camping privileges.
- 40. Campsites must be vacated and cleared by 11AM on November 1.

## FEES

A 3 month deposit is required within 10 days of making a reservation. The remaining 4 months balance will be due prior to April 1 (opening day.) The fees may be mailed to Chatuge Woods Campground P.O. Box 1044 Hiawassee, GA 30546. Make check or money order payable to Towns County. To pay by credit card call 706-994-1533.

Open season is April-October. The gate will not be opened for early admittance regardless of what day of the week April 1 is on. The gate opens at 9 AM on April 1.

CWC is for recreational purposes only. A campsite may not be used as a primary residence. All persons camping must have a permanent address elsewhere.

Water levels drop periodically after July 4<sup>th</sup>. It is recommended you check your boat often to ensure that it doesn't dry dock. After Labor Day, the lake water level drops drastically. It is recommended that you monitor your boat daily to ensure it doesn't become "beached" for the winter.

I hereby certify that I have read and understand the rules for Chatuge Woods Campground. I understand that in the event I violate any of the rules, I may be given one warning from the campground Manager, and if after such warning, I continue to violate the rule(s), I and my camping group may be instructed by the Campground Manager to vacate the premises immediately or within a time frame given by the Campground Manager. I hereby certify that I will comply with said request quietly and without incident. I agree to return on a date and time specified by the Campground Manager to retrieve and remove my camping unit and/or all camping equipment from the campground quietly and without incident. I also understand that if the manager has issued warnings I may be denied future camping privileges.
