Christopher Columbus: Hero or Villain?

The second Monday on October is no longer in many major cities being celebrated as Columbus Day, but rather is Indigenous People's Day. Many school textbooks still present Christopher Columbus as the famous Italian explorer who discovered America, but history painted a much more complicated picture. Was this man from Genoas a brave explorer or a greedy invader? A gifted navigator or reckless adventurer?

Columbus never discovered America. Even if you were to overlook the fact that millions of people were already living in North America in 1492, the fact that Columbus never set foot on our shores. In fact, this day in October marks the day of his arrival to the Bahamas. While he did also reach the shores of Cuba, Haiti, and the Dominican Republic, as well as explore the Central and South American coasts, he never unfurled a Spanish flag in North American. Leif Eriksson is the first European believed to have sailed the North American, having reach Canada 500 years before Columbus set sail to the west.

Columbus may never have reached Asia as planned, but one cannot discount the sheer will required to make his journey. At the age of 41, he defied naysayers across Europe and led four voyages across an unchartered ocean in wooden sailing ships that were not designed to take on the waters of the Atlantic.

In 1492, most educated Europeans already believed the earth was round. In fact, it was an idea that had been established by the Ancient Greeks in the 5th century BC Contrary to popular myth, Columbus did not set out the prove the world was round, but rather that it was possible to sail around it, a voyage the explorer drastically underestimated.

Columbus also stood to gain significant wealth and power from his voyage, terms he negotiated with King Ferdinand and Queen Isabella of Spain. His contract with the monarchs, call the Capitulations of Santa Fe, named Columbus the admiral, viceroy, and governor of any land he discovered. It also stated that Columbus could keep 10 percent of any "merchandise, whether pearls, precious stones, gold, silver, spices and other objects" that he "acquired" within the new territory. Columbus may indeed have noble intentions when he sailed west, but his agreements with Spain suggest his intentions where far from selfless.

When Columbus first set foot on Hispaniola, he encountered a population of native people called the Taino. A friendly group, they willingly traded jewelry, animals, and supplies with the sailors. "They were very well built, with very handsome bodies and very good faces," Columbus wrote in his dairy. "They do not carry arms or know them. They should be good servants." The natives were soon forced into slavery, and punished with the loss of a limb or death if they did not collect enough gold. Between the European's brutal treatment and their infectious diseases, within decades, the Taino population was decimated.

Finally in 1499, the Spanish monarchs heard of the mistreatment of the Spanish colonists in Hispaniola, including the floggings and executions without trial. Columbus, was arrested, chained up, and brought back to Spain. Columbus admitted to his wrong doings and was stripped of his title of governor.

Minutes from the September City Council Meeting

City of Gaylord - Minutes of September 13th, 2017 Regular Meeting

The Gaylord City Council met in regular session in the Community Center at 7:00 p.m., September 13th, 2017.

Present Members: Barb Lehmann, Jim Muck, and Wil Neussendorfer Absent Members: Gene Casteel and Wendell Felsburg Presiding: Mayor David Tucker Present also: City Clerk Aubrey Neussendorfer, Treasurer Crystal Ifland, and City Man Ed Burt.

Mayor Tucker called the Regular Meeting to order at 7:00 p.m.

Citizen's Report: none

The minutes of the August 9th Regular Meeting were read. Wil made the motion to approve the minutes as read. Barb seconded, motion carried.

Mayor Tucker called for the reading of the bills. After discussion, Barb made a motion, seconded by Wil, to approve payment of bills, including any routine bills outstanding. Motion carried. Bills paid out \$16,126.93.

Mayor Tucker asked for a report of utility arrears: Richard Bose, Darin Godsey with three accounts, Rita Gorman, and Mike Fogo. One account #80 was disconnected.

Account 44 still remains unpaid and has been disconnected. Collections procedures have begun.

OLD BUSINESS:

- Updates for the WCA Door Project were made. Aubrey reported during the past month Center Glass requested a \$3000.00 deposit for the door as delays are starting to cause a problem. Gene and Ed have plans to finish the trim work in the next few weeks. Aubrey will report to council next month with estimates and ideas for the signage/plaque to recognize all funding sources for this project.
- Estimates for concrete work around the Community Center were reviewed. One is the for the northwest corner for a display and the second includes filling in the rocky area between the building and the sidewalk along the entire west side of the building and removing/replacing the sidewalk along the southwest corner of the building. Before council decides to pursue more estimates are needed for landscape rock and dirt work.
- Fall Grant for a back-up generator for the Community Center was discussed. Aubrey asked council if the new Fire Station should also be included in this grant as this building would also be used as an emergency shelter and to combine these two projects into one larger project. Council agreed to combine this project for the grant process.
- Jim updated council on information Gene has found concerning the Holmes Addition Project. Gene has spoken with the property owner of the vacant lot next to the current drainage area about purchasing this lot to relocate the drainage ditch, but the current owner is not interested in selling the property, but would allow for an easement to relocate the ditch right next to the current ditch. Gene had also spoken with our city attorney and they advised to not have easements but to purchase the land. Barb made the motion to have Aubrey contact land surveyors and to go ahead and have the area surveyed with the company who is cost effective and can perform the task within a reasonable time frame. Jim seconded, motion carried.
- Aubrey updated council with the estimate for the Credit Card Option for the Metermaid System from Johlin Measurements. Ed reported to council his findings of what is needed to install this system in well 6 well house. Barb made the motion to purchase this bulk fill station system, SmartVend SmartCard System with the options totaling \$13,492.50. Wil seconded, motion carried.
- Aubrey reported the letter concerning the issues with a recent Community Center Rental had been sent.
- Aubrey reported no news has been received from the Water Tower Company as of yet. Ed reported when the water tower is being worked on if the generator should be moved to the well house in case we would lose power. Council agreed the generator should be moved during this time.
- Aubrey asked council if any changes need to be made to the street lights at this time. No changes were requested at this time.
- Aubrey reported she continues to make good progress in scanning in the office.
- Aubrey reported Fire Chief Horning had prepared a job description for his position and a copy of this was in the handouts for the meeting. Aubrey reported Chief Horning had included a couple of items which he would recommend for council to consider concerning an annual report for all fire apparatus if in the future the elected Fire Commissioner is not a member of the fire department, and purchasing procedures. Council asked Aubrey to thank Chief Horning for his work on this job description and to submit his recommendations for his replacement at the October Meeting. These Can either be in writing or he Can attend the meeting to give them verbally.
- Ed reported was able to repair the battery on the siren and it is now working.
- Aubrey & Wil reported on the ISO Meeting they attended in Junction City on August 23rd.
- Aubrey asked council if they still wished to pursue the Mobile Home Ordinance After discussion council asked for more research to include other items such as tiny home, trailers, and campers for example.
- Aubrey reported concerning dogs, if no boarding facility was located to take the dogs to then the city would need to build a shelter to house these animals and this would need to be licensed with the state and be at least inspected annually.

NEW BUSINESS:

- After discussion, Wil made the motion to begin using KANPAY to process credit/debit cards and to no longer use Square Reader. Barb seconded, motion carried.
- Aubrey asked council if they wished to pursue anything with the bikes which are frequently rode on sidewalks. Council wished to take no action at this time.
- Aubrey asked council if they would like to plan any events for Halloween this year. After discussion council agreed to host the Pumpkin Decorating/Carving Contest, and to host a Community Trick-Or-Treating Community Party on Sunday October 29th from 2 to 4 pm at the Community Center.
- In November there will be a county wide Emergency Management Planning Meeting and members of council are invited to attend if possible.
- Aubrey reported Smith County Community Foundation in conjunction with Dane G. Hansen will be issuing Community Clean-Up Grants for individual cities to apply for with funds up to \$10,000. Council is interested in applying for these funds.
- Aubrey reported two CMB Licenses for Dave Hommon will expire the end of September and if council would like to pre-approve these renewals as long as all required information and payments are received by September 31st. Wil made the motion to pre-approve CMB licenses for Dave Hommon for off-sale and on-site consumption as long as all information is received by September 31st, 2017. Barb seconded, motion carried.

REPORTS:

STREETS: Ed reported he is still planning on hauling rock and would like to have a stock pile built up in town before winter. Mayor Tucker reported there are culverts in town which still need to be cleaned out. Wil & Ed explained to council the intentions members of the fire department to re-direct water from the new fire station south across Main Street. Current culverts under Main Street will be located and either re-opened or new ones will be installed.

SEWER/TRASH: no report

WATER: no report

FIRE: Wil reported the department had no runs during the past month. New pagers are now being used by all members. The tanker currently is out of commission as it has fuel in the oil. Arrangements are being made to have the truck worked on.

HOUSING/COMMUNITY CENTER: Barb reported 6 units are rented at the Housing Authority.

PARKS: David asked Ed to begin watering the brown spots. Fall maintenance of spraying was discussed.

CITY MAN: Ed told council he would be gone Friday September 15th, 2017.

TREASRUER: no report

CITY CLERK: no report

Mayor Tucker stated the next council meeting will be October 11th, 2017 at 7 p.m.

With no further business before the council, a motion was made by Wil and seconded by Barb to adjourn. Motion carried and meeting so adjourned.

Meter Maid System

During the September City Council Meeting, council made the motion to purchase a new meter maid or bulk fill water station to be installed on Well #6. At this time, council anticipates this system to be functional by the end of October. The biggest change to this system will be, no money (coins or currency) will be collected at the well house. This system will operate from pre-paid cards which will need to be charged at the City Office. These cards will work like pre-paid credit cards. Council is looking forward to this new system and wishes all will enjoy the updated system. Unfortunately the main reason Council decided to upgrade the system we currently use is the loss of water which is not paid for from the meter maid has reached a point council is no longer willing to overlook. The Hutchison Public Library is allegedly hauted by a former librarian names Ida Day. Ida was famous in her day for her seriousness and stoic demeanor, in both life and death. Ida is not a violent or harmful ghost and is often see walking aorund, looking and/or sorting books.

4. Hamburger Hill in Hutchison, Kansas

Since the 1950's, visitors of the sand hills north of Hutchison have been careful not to stray too far from the hiking trails, as they may encounter the deformed figure of Hamburger Man. Half ghost, half monster, the Hamburger Man has stalked his way through many local generations.
