City Council Minutes

October 3<sup>rd</sup>, 2016

The City Council of the City of New Munich met in regular session at 6:30 p.m., in the City Hall. Jim Poepping, Shawn Duevel, Pat Nathe, and Dan Krueger were present, Ron Doll was absent.

On a motion by Jim Poepping, seconded by Shawn Duevel and carried the minutes from September 6<sup>th</sup>, 2016 were approved.

Fire Chief, Allen Fiedler was present to inform the Council on 3 medical calls last month. Allen has a meeting with ISO to go over trucks, training and call records. Allen submitted a bill that needs to be paid from Fire Safety USA \$3615.00.

On motion by Dan Krueger, seconded by Pat Nathe and carried Resolution 10-16-A was approved.

Waste/water Operator, Tom Valerius was present to inform the Council that he will be doing basic maintenance on the pond, (vegetation control). The Lift Station on Munich St had a communication problem. Preferred Controls came out and notice the antenna was installed upside down. They double checked the other two lift stations to see if they were installed correctly. On October 19<sup>th</sup> Tom will be attending the MN AWWA Central District Operator Training. On October 1<sup>st</sup> they flushed the dead-end lines and had about one minute of rust until the water became clear.

Tom will have R-Way Pumping flush all the lift stations before winter.

On a motion by Pat Nathe, seconded by Dan Krueger and carried the following building permit was approved, Barb Nathe.

Ray Painter was present and asked the Council about the outdoor events at the bars. The City clerk informed him that they are using their catering license to hold the event. She also informed him that she double checked with the City Attorney to make sure this was not a violation of the City Ordinance. He asked if he could get a copy of what the attorney wrote. The City Clerk will email him a copy of the letter.

The Council would like to set up an Annual meeting with Greenwald insurance for any question they might have.
