  - Governor Hobbs and cities are discussing ways to manage this loss of revenue
- Discussion of adding a fare to ride the streetcar
  - Discussion taking place with Mesa to expand to Cubs stadium
  - Depends on tax passing in November
  - Original route was supposed to go south on Mill to Southern but the FTA said we didn't have the ridership for federal funding
- The mayor expressed his gratitude to TSA employees for our hard work
