Handling: I agree to keep my dog on leash at all times and at least 6 feet away from other dogs.

Attendance: The entire family is welcome to attend. Children under 16 must be accompanied by an adult, and young children must be supervised remaining calm, quiet and under control.

Vaccinations: I will keep my dog current on the required vaccinations and provide proof of such. Adult dogs are required to be current on DHPP/Combo, Bordetella and Rabies prior to attending.

Behavior: I understand that overly aggressive dogs cannot participate in the group class and I will abide by any of the instructor's decisions regarding dismissal. I have disclosed any aggressive behavior such as growling, snapping, and bite history.

Payment: I agree to pay the full amount for the class on or before the first class to Honey Creek Pet Resort LLC (dba Central Missouri Canine Solutions). Cash, checks, Visa, Mastercard and Discover are accepted as payment. Checks returned due to non-sufficient funds are subject to a \$25 fee.

Cancellation: I understand that I need to contact Central Missouri Canine Solutions at least 48 hours prior to the first private session to be eligible for a full refund of the class or package fee.

Refunds: I understand that no refunds will be issued after the first class or private session is completed. If for some reason the student is unable to complete the course, a prorated transfer certificate (valid for one transfer usable for up to 1 year) will be issued for a future class/package.

Service Guarantee: By completing the training program and the agreed upon commands identified in this contract, I may obtain reinforcement training of these skills for the life of the dog. This does not include training of more advanced skills, new commands, or behavior consultations.

Behavior/Training Guarantee: I understand that dog behavior is not fixed and as such no guarantee can be made that my dog will retain its training without my own participation in continuing training at home as directed, nor that the training will last for a particular amount of time. I acknowledge that it has not been represented, promised or guaranteed to me that my dog will never bite, be considered dangerous or vicious in the future, or that my dog will not exhibit other behavior problems.

Release: I agree to indemnify and hold harmless Honey Creek Pet Resort LLC dba Central Missouri Canine Solutions, its members, employees, agents, instructors and staff members from any and all claims for loss or injury, or liability of any kind should any of these occur to myself, my dog, my family or assigns. I further agree to assume all responsibility and liability for any loss, injury or damage done to other dogs, persons or property by myself, my family, my assigns or my dog.
