GOLF COURSE TREATMENT SCHEDULE

YEARLY DOSAGE RATES

GREENS & TEES: For initial application, start the season early with 16oz/1000sq ft. on your best greens. In season, apply weekly or bi-monthly at the rate of 2-4 oz. per 1000sq ft. on greens, tees, and fairways. Add iron, nitrogen, biostimulants, seaweed, etc. For monthly treatments, put 3 gal. Surf Side 37 in the 100 to 160 gal. spray tank and cover 6 average greens. Follow with syringe or normal watering.

warm water and pour directly onto the LDS. If needed, punch holes to speed up penetration. Drench all turfgrass areas not up-to-standard with 2 quarts Surf Side 37 in 100 gal. water. Surf Side 37 per acre. Best applied in a steady rain using no less than 100 gal. water in the spray tank. Should the rain stop, follow closely with normal fairway irrigation.

SURF SIDE PELLET: 80z/98% active. Don't syringe without them. Keep control of localized dry spots. Revitalize hard-to-wet areas.

SODDING: Surf Side PELLETS jumpstart sod and speed return to play. Pellets help knit sod to soil base and move free moisture from soil interface. Pellets promote rooting across interfacial barrier. When laying washed sod, do not use Pellets for all water during establishment.
