The Kaw Valley Football and Cheerleading Club (KVL) is now accepting registrations for youth tackle football and Cheerleading. Space will be limited. Preference will be given to players who have previously played in KVL .Whenever possible; players will be assigned to teams according to the school or school district they attend. Final Rosters will be decided by the KVL Commissioner. The KVL will be part of the Sunflower Football Conference. All coaches will be approved by the KVL Commissioner. Games will be played on Saturdays at the Field of Dreams located in Basehor, KS and other facility's in the area. Each team will play a minimum of seven (7) league games (weather permitting or medical Issues). At the end of the season all teams will advance to a League Super Bowl or a Bowl game. League play will begin on September 10,2022 The KVL will provide insurance, awards (for all players and cheerleaders), referees, and a well maintained facility. Each player will provide their own football equipment (rental is available), mouthpiece, shoes, jersey, football pants w/pant pads and athletic supporter (The KVL will have a limited supply of equipment available to rent) The league will be divided into the following divisions (subject to Change) Flag (K-2nd Tackle will be grades 3rd grade, 4th grade, 5th grade, 6th grade. The KVL League Commissioner will rule on all issues not clearly stated in league rules. All players must have a current athletic physical (completed in 22), proof of 2022 grade and a copy of their birth certificate
