PIRST AMENDMENT TO THE DECLARATION OF CONDOMINIUM CORD SUFFERING SOLET CLERK

This First Amendment made and entered into this 1st day of November, 1990, by Township at Powers Ferry, Inc., hereinafter referred to as "Township".

WITNESSETH

WHEREAS, that certain Declaration of Condominium for Powers Ferry Green, a Condominium, hereinafter referred to as the "Declaration", was made and entered into on July 15, 1985, by BPI Construction Co., hereinafter referred to as "BPI", and was filed and recorded July 16, 1985, in Deed Book 3569, page 1, Cobb County Records; and

WHEREAS, the plat (site plan) for Powers Ferry Green, a Condominium, hereinafter referred to as the "Condominium", was recorded simultaneously therewith in Condominium Plat Book 4, page 190, aforesaid Records; and

WHEREAS, the plans for the Condominium were recorded simultaneously therewith in Condominium Ploor Plan Folder No. 85-009 A, aforesaid Records; and

WHEREAS, Township became the Declarant, as such term is defined in the Declaration, and the successor in interest to BPI, by virtue of that certain Warranty Deed dated March 31, 1987, filed and recorded April 7, 1987, in Deed Book 4409, page 42, aforesaid Records; and

WHEREAS, the Declaration provides in Paragraph 2.05 thereof that the Declarant may submit to the provisions of the Declaration any and all of the Additional Property as such term is defined in the Declaration; and

WHEREAS, certain condominium units have been developed on the Additional Property and were never submitted to the Declaration as provided for therein; and

WHEREAS, Township now desires to submit to the Declaration such units and the Additional Property upon which they are located;

NOW, THEREFORE, in consideration of the covenants contained herein and in the Declaration, One and No/100ths (\$1.00) Dollar and other good and valuable considerations, the receipt and sufficiency of which are hereby acknowledged, the undersigned hereby states as follows:

(1) That certain property described on Exhibit "A-1", attached hereto and by this reference made a part hereof, is hereby

submitted to the provisions of the Declaration, and shall be and become a part of the Condominium. Furthermore, all units located upon such property described on Exhibit "A-l" hereto which have previously been conveyed from Township to bona fide purchasers shall be considered part of the Condominium from and including the dates of such conveyances, subject to the rights, if any, of such purchasers and/or their mortgagees.

- (2) The Plat (site plan) for the Condominium shall hereinafter refer to that certain plat entitled "As-Built Survey of Powers Ferry Green Condominiums" prepared by E. A. Anderson & Associates, dated August 29, 1987, and recorded in Condominium Plat Book 5, Page 68, aforesaid records.
- (3) The plans for the Phase II property shall mean and refer to those certain plans recorded in Condominium Floor Plan Folder Number 85-009 A, aforesaid records.
- (4) Exhibit "C" attached to the Declaration is hereby deleted in its entirety and the new Exhibit "C", attached hereto and by this reference made a part hereof, is hereby added to the Declaration. All references to Exhibit "C" contained within the Declaration and this Amendment shall mean and refer to the new Exhibit "C" hereto.
- (5) The number of votes in the Association, as such term is defined in the Declaration, is hereby increased to fifty-six (56), with each Condominium Unit having one vote in the Association.

EXCEPT AS AMENDED HEREBY, all other terms, covenants, rights, conditions and obligations of the various parties in and to the Declaration shall remain in full force and effect and are hereby ratified and confirmed by Township in its capacity as Declarant.
