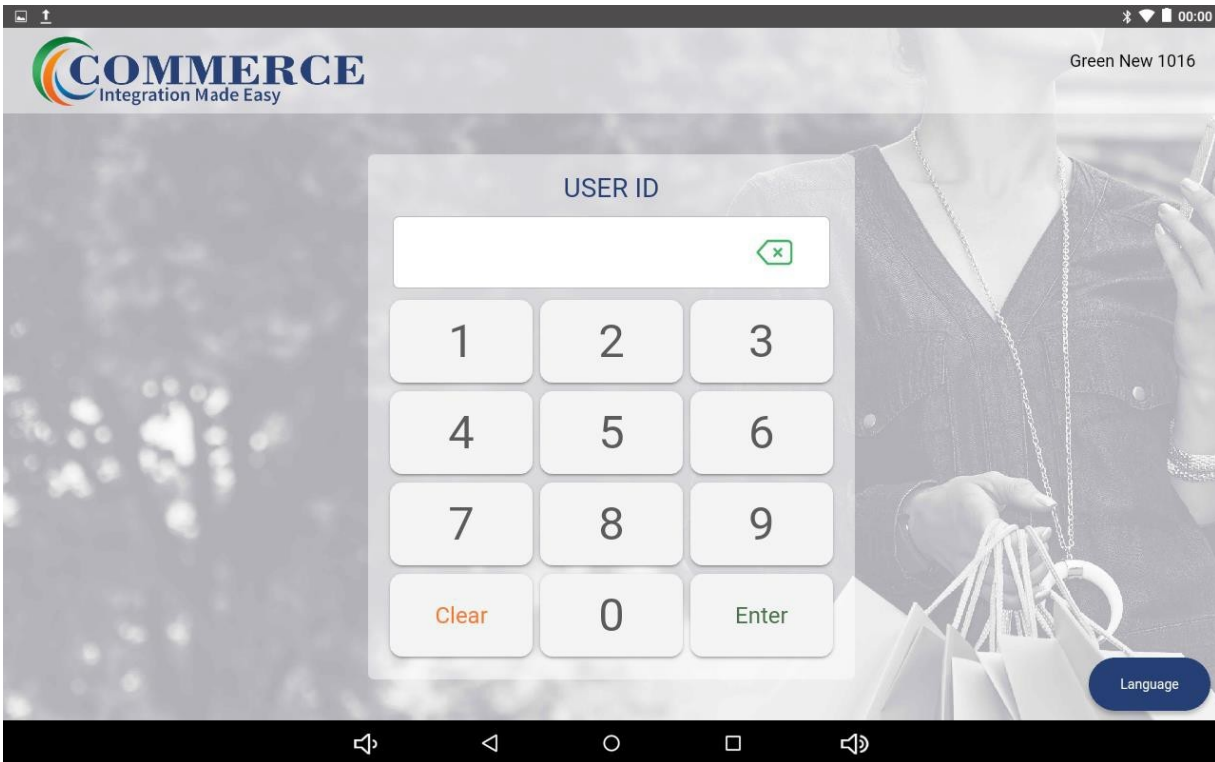

3. Login

Users can enter the system by logging in. There are two login methods.

1. Enter the user ID and password manually to log in. Admin receives password from Seamless Commerce Setup and Configuration via email. Additional users can be setup using the Simple Register App with an upgraded solution.



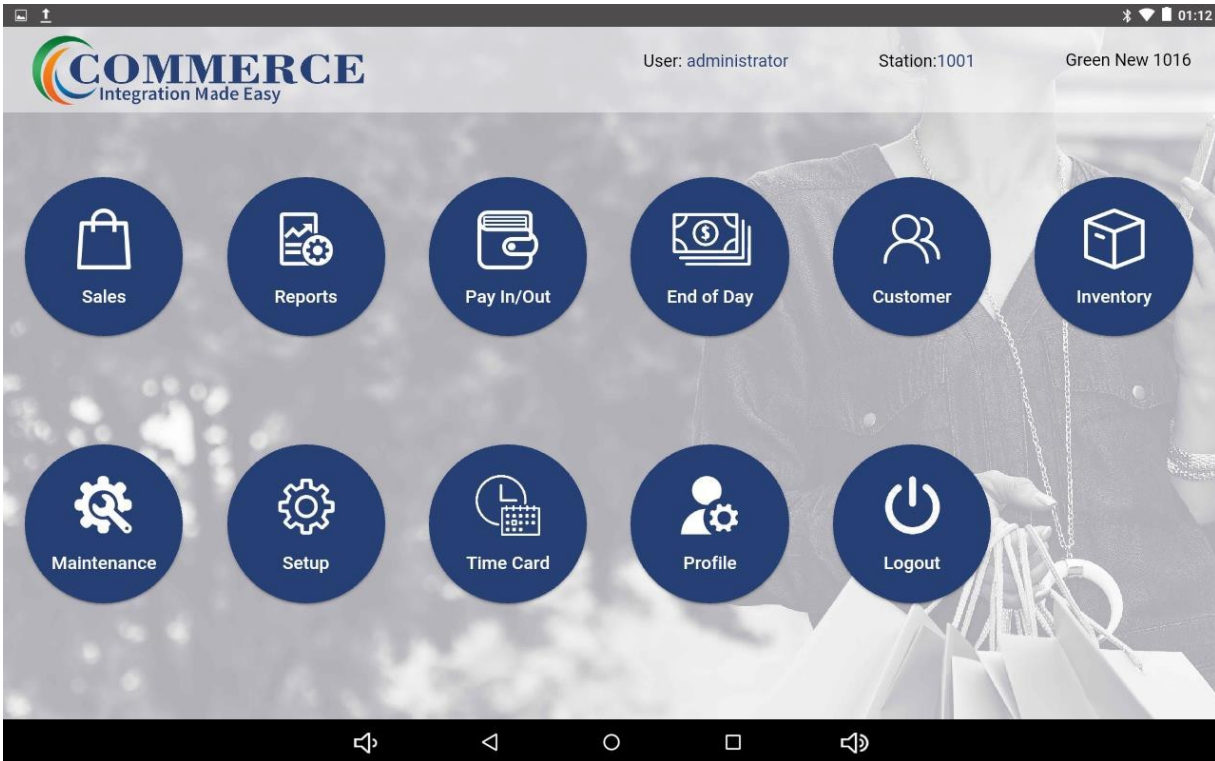
2. Use the Scanner to scan the user's barcode on the login screen to log in. Notes: When you add a user, a barcode is generated for the user to log in (which can be printed upon setup of that user). Please refer to User setup section on page 25 for additional information.

The Main Menu displays after a successful login.

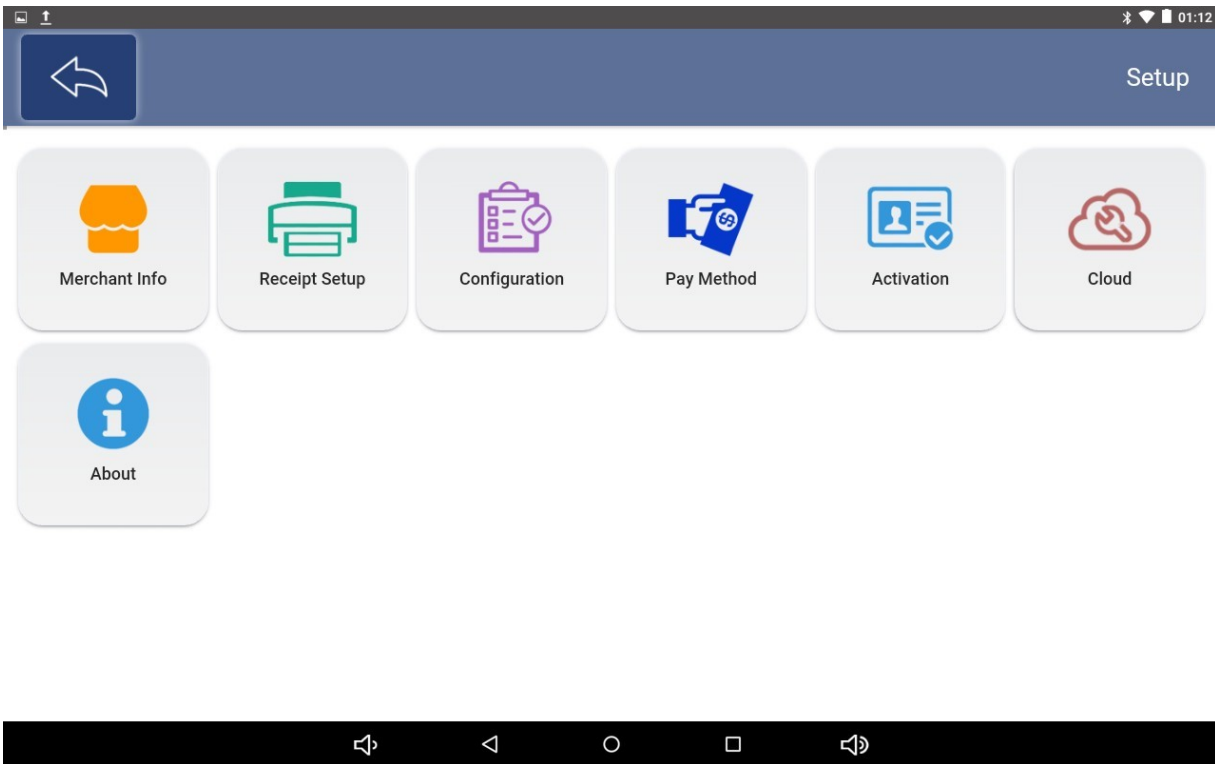
4. Setup/Settings

1. From the **[Main Menu]**, Select **[Setup]** then Select **[Merchant Info]**.

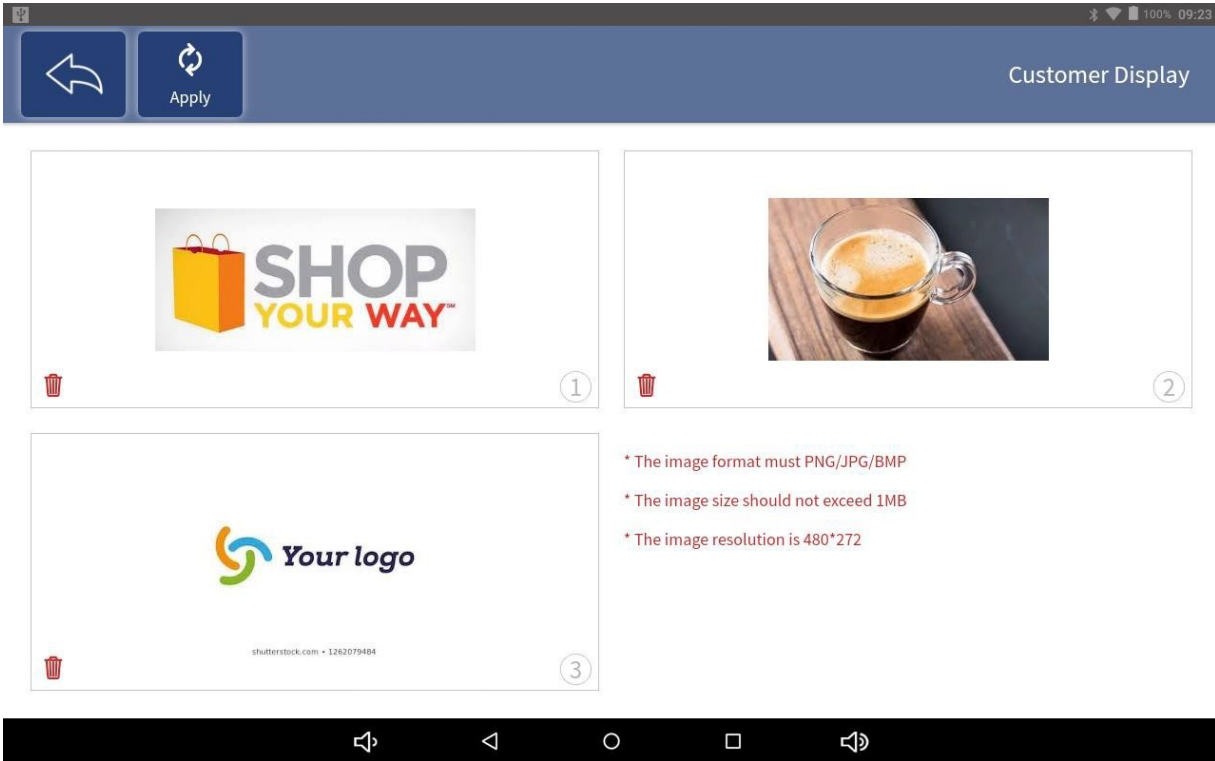



- **Tip:** When Toggle switch is turned on, to enable tip
- **Barcode:** When switch is on, a barcode will print out at the bottom of the receipt. This Barcode can be used to recall transactions by using the barcode scanner.
- **Copy:** Set the number of tickets to print.
- **Header:** Select the add button, to provide a message in the "Header" position. Footer: Select Footer Tab, and select add button, to provide a message in the "Footer" position. I.e. terms of sale or other messaging.

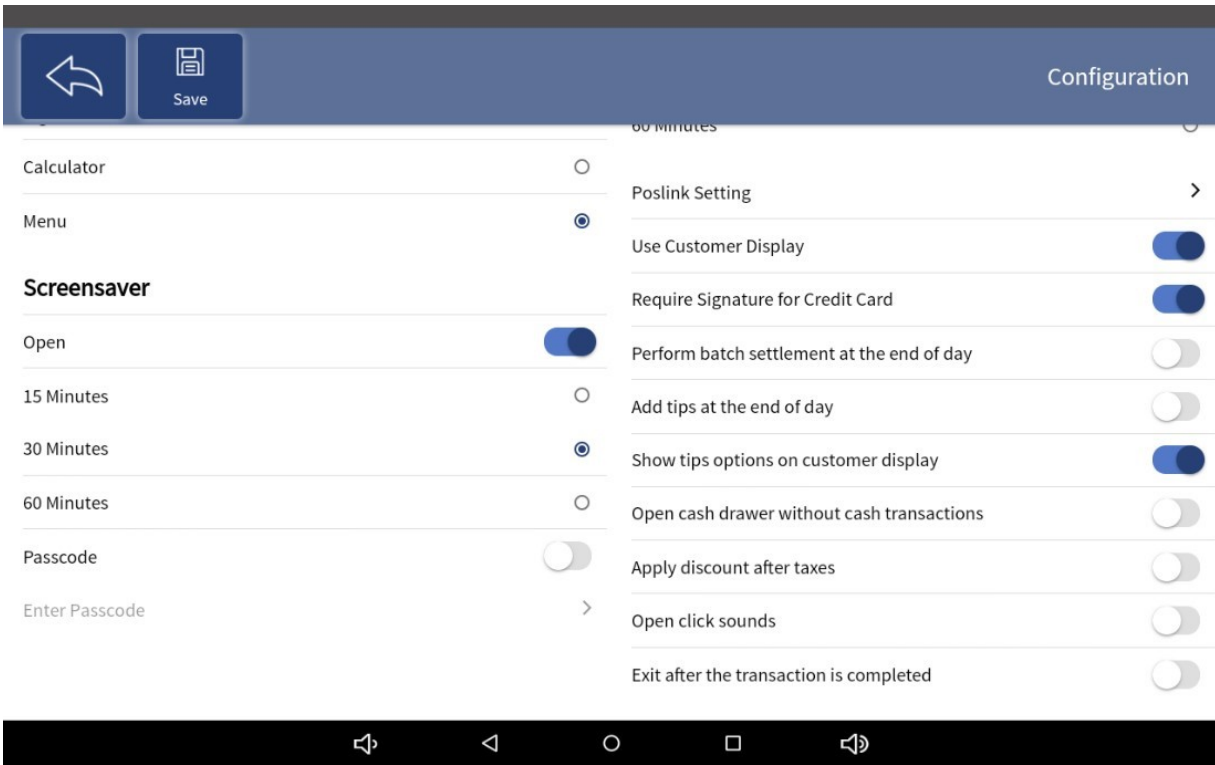

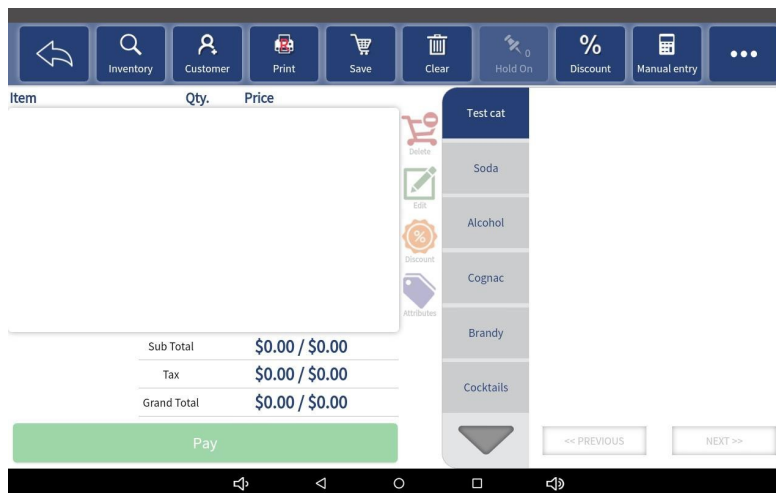

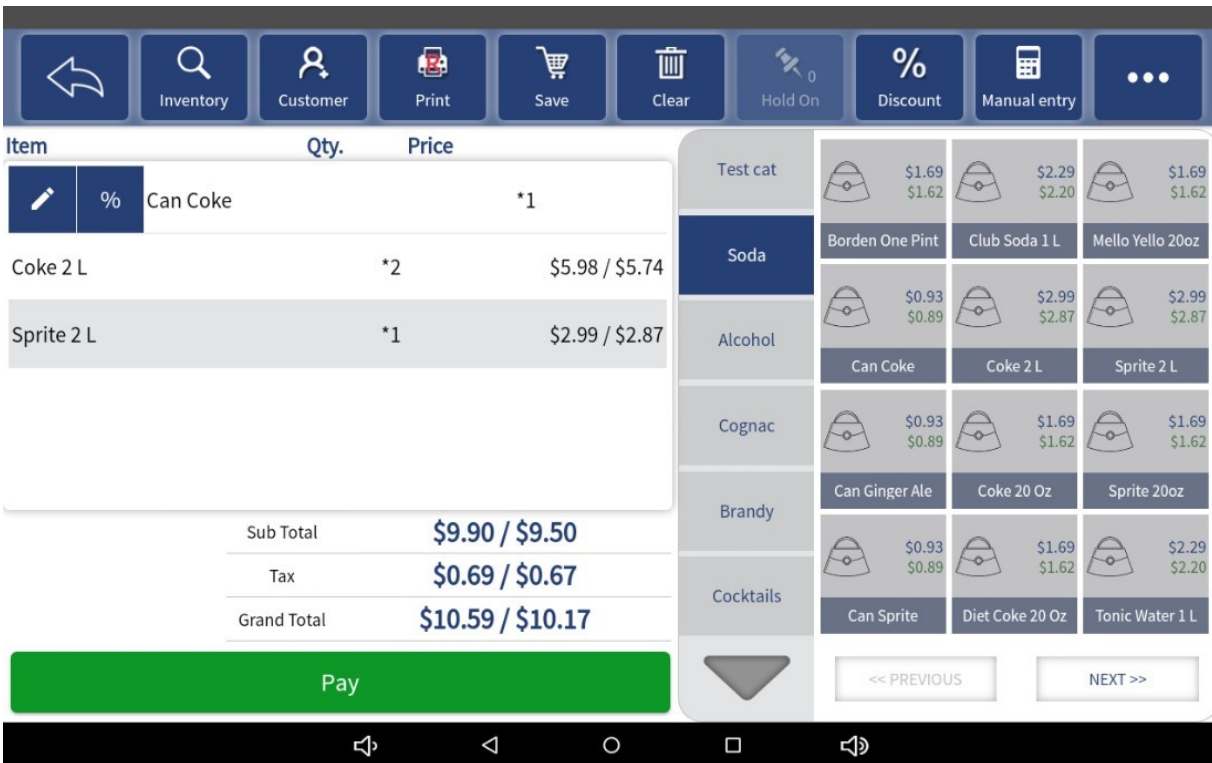
Sale Screen Mode: Within the Sales page. Select how individual items can be modified, deleted, edited, discounted.

Item Operation

- **Traditional:** This mode fixes the operations such as Delete, Edit, Discount, and Attributes in a small column position in the middle of the page.



- **Popular:** In this mode, Select the desired operation such as Edit, Discount, and Attributes by sliding the single item in the shopping cart right and left to Delete.



Right Side: On the right side of the Sales page, there are two settings by default, "Menu" or "Calculator".

- **Calculator:** Set the right side to the mode of the Calculator by default.
- **Menu:** Set the right side to the mode of Menu by default.

Screensaver: Toggle on and select a suitable time period.

Passcode: Set a password which are used to enter the system during screen saver.

Exit when it is idle: Log out automatically after a period of idle time. If enabled, a suitable time-period must be selected.

When Enabled:


- **Use Customer Display:** The customer can see the actions in Sales, such as adding items to the shopping card, re-editing the item information in the shopping cart, returning operations,
- **Require Signature for Credit Card:** Customers are required to sign on the customer's display when paying by credit card.
- **Perform batch settlement at the end of day:** The Q20 will send batch settlement to the bank at End of Day.
- **Add tips at the end of day:** The Add Tips button appears on the End of Day page.
- **Show Tip options on Customer Display:** Customer can add tip to transaction

- **Open cash drawer without cash transactions:** Users can open the cash drawer without a cash transaction.
- **Apply discount after taxes:** The tax amount of the item is the original price of the item multiplied by the tax rate, and it will not change due to price changes caused by the promotion of the item. Conversely, when not enabled, the tax amount of the item is the final price after the discount multiplied by the tax rate.
- **Open click sounds:** The system's touch screen sound is turned on.
- **Exit after the transaction is completed:** The user will automatically log out of the system when a transaction is completed.

Note: After completing the changes, Select the Save button to save all changes. Re-login is forced and is required for these settings to take effect.

Cash Discount: Cash Discount provides a discount for transactions where Cash payment method is selected. If set On, enter amount of discount.

Markup: Set on/ off, if set on enter amount of discount Change all items in inventory by percentage

Cash Back: Set on/ off, if set to On Enter Max Amount of Cash Back. Ie EMV Pin Required, EBT Pin Required

Pay Method:

- **General:** When checkbox is select payment type will appear as an available payment selection upon checkout.
- **Cash Discount:** When checkbox is selected this payment type will be enabled for Cash Discounting.

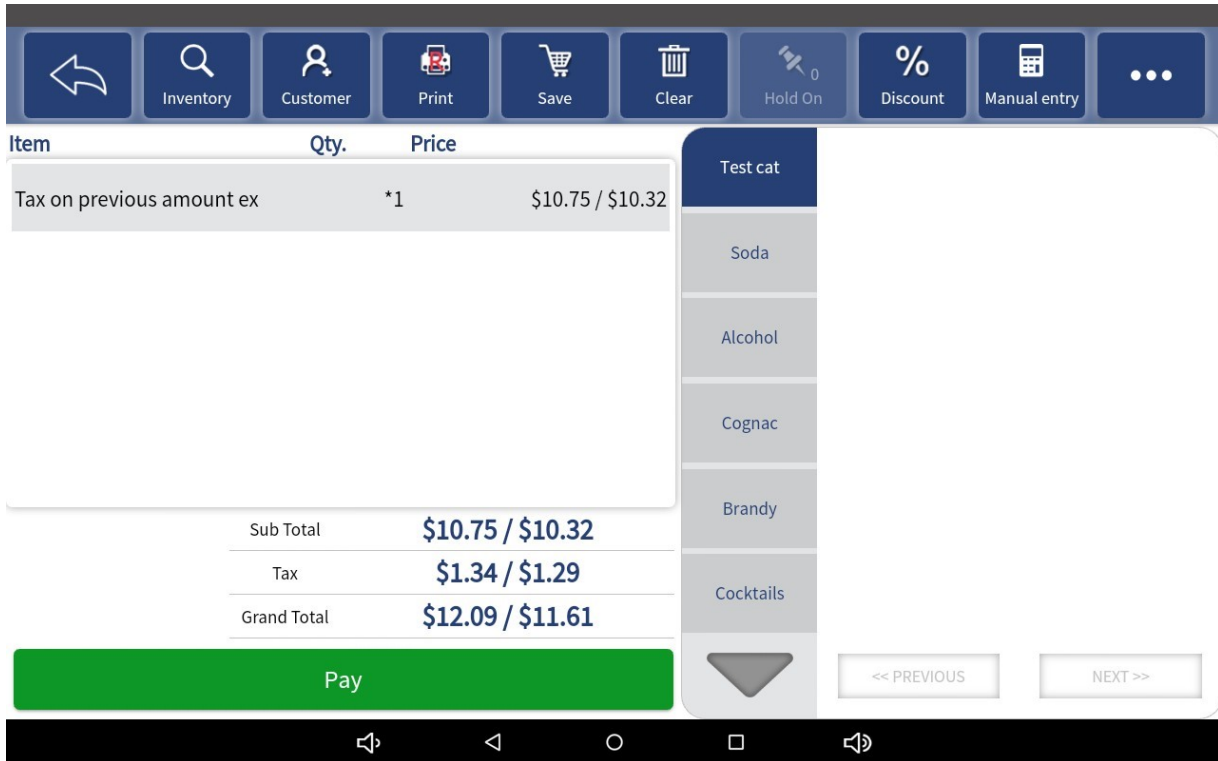



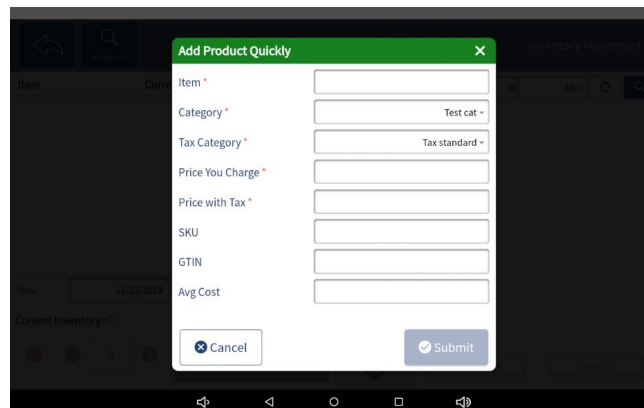

6.1 Users

Manage the store's User accounts for Employees.



Refresh: Refresh the current Users list.

Add: Add a User to the current store by clicking the "Add" button.

1. Enter required Name and Role for the User
 - Other information can be optionally filled according to your needs,
2. Click the "Save" button above to save.

Delete: Select a User in the list on the left and click the "Delete" button to delete User.

Save: This button is used to save changes after editing, adding, and deleting Users.

New Password: Click this button to change the login password for the selected User.

Print: To print out the Login Scan Code of the selected User. Select Print. Barcode will be printed. User can then use barcode which has been printed to clock in/clock out.

Note: User ID is generated by system and cannot be reused once deleted

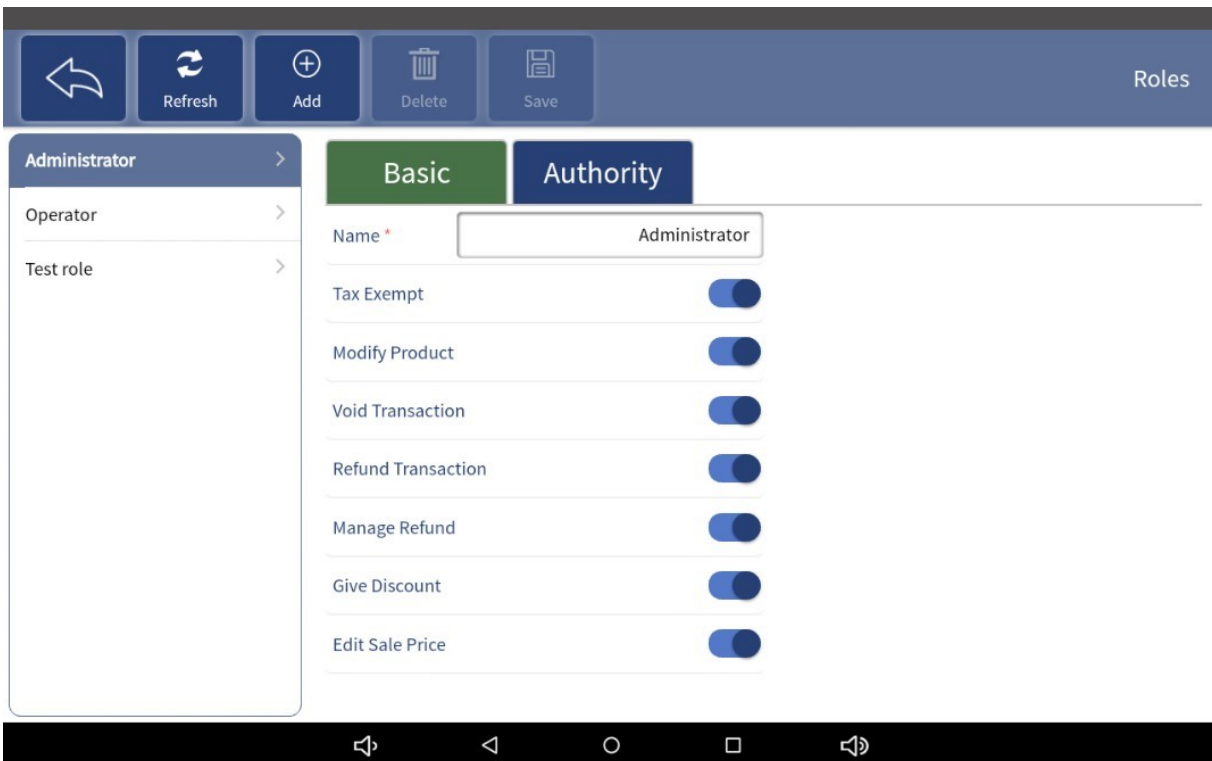
6.2 Roles

The list on the left side of the page shows all the Roles under the current store, and the right side is the permission information corresponding to the Role.

Roles: Define user access for a based upon selection of permissions.

Basic: This tab shows the basic information of each Role, Permissions such as the options listed below can be enabled by toggling on option.

1. Name
2. Tax Exempt
3. Modify Product
4. Void Transaction
5. Refund Transaction
6. Manage Refund
7. Give Discount
8. Edit Sale Price



Refresh: Click this button to refresh the current Roles list.

Add: Add new Roles.

- Enter the required name,
- Choose the appropriate permissions and authority
- Click the "Save" button above to save.

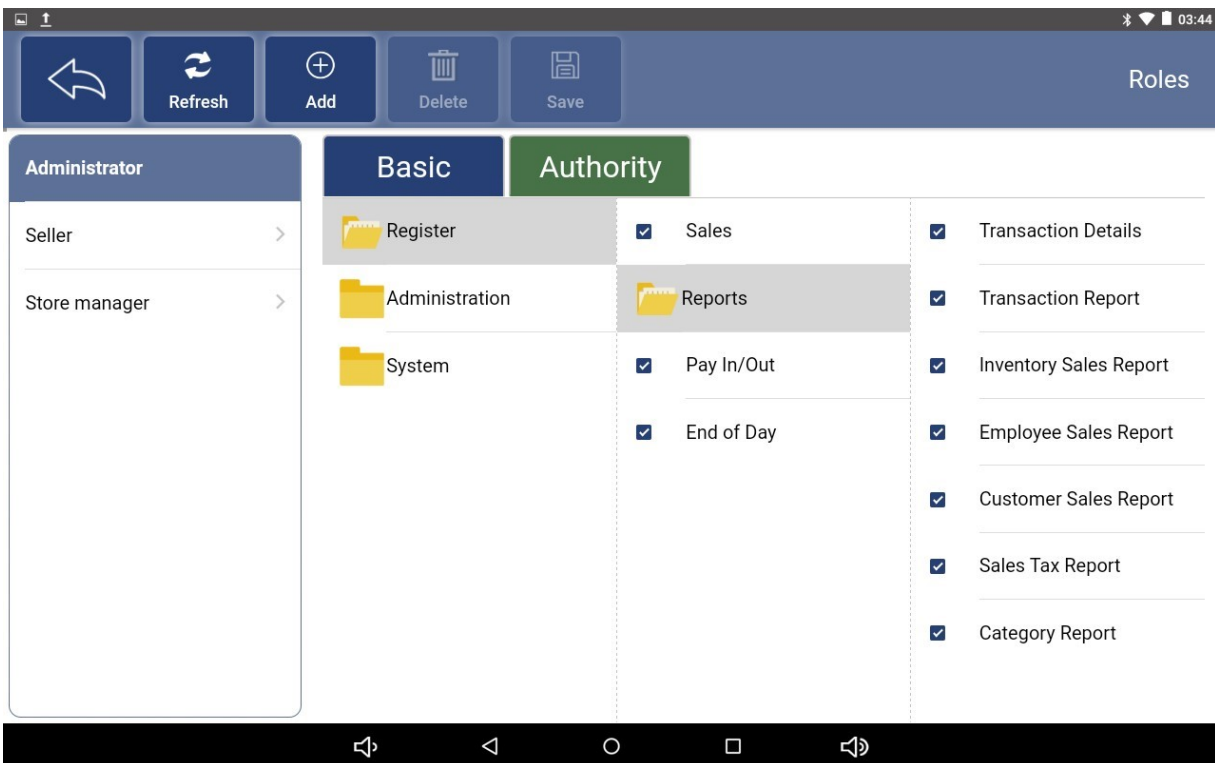
Delete: Select a Role in the list on the left and click the "Delete" button to delete it.

Save: This button is used to save changes after editing, adding, and deleting Roles.

*Note: Any Modifications to Roles requires a save otherwise it will revert back to previous values

Authority: Tab allows the Administrator access to permission the entire tree of the system. Administrators can provide permissions or change permissions to any role. Ensuring that each user has the appropriate level of access.




6.3 Global Price Change

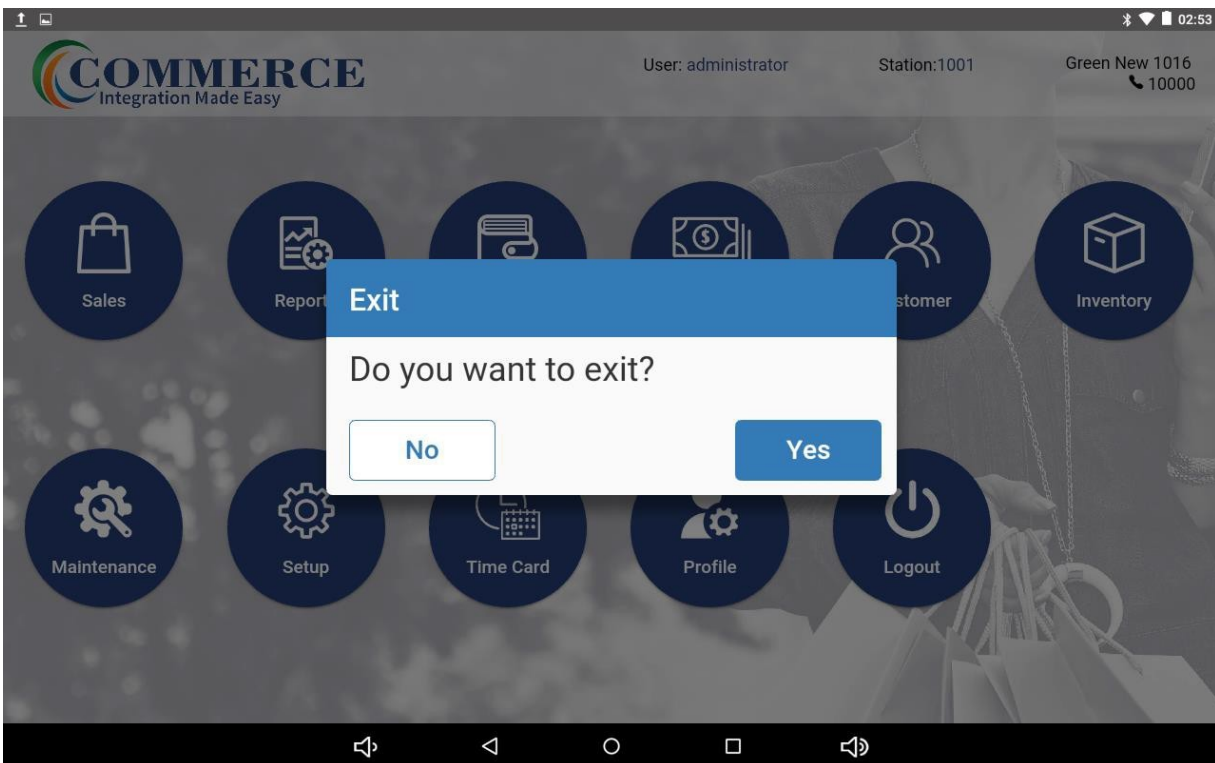


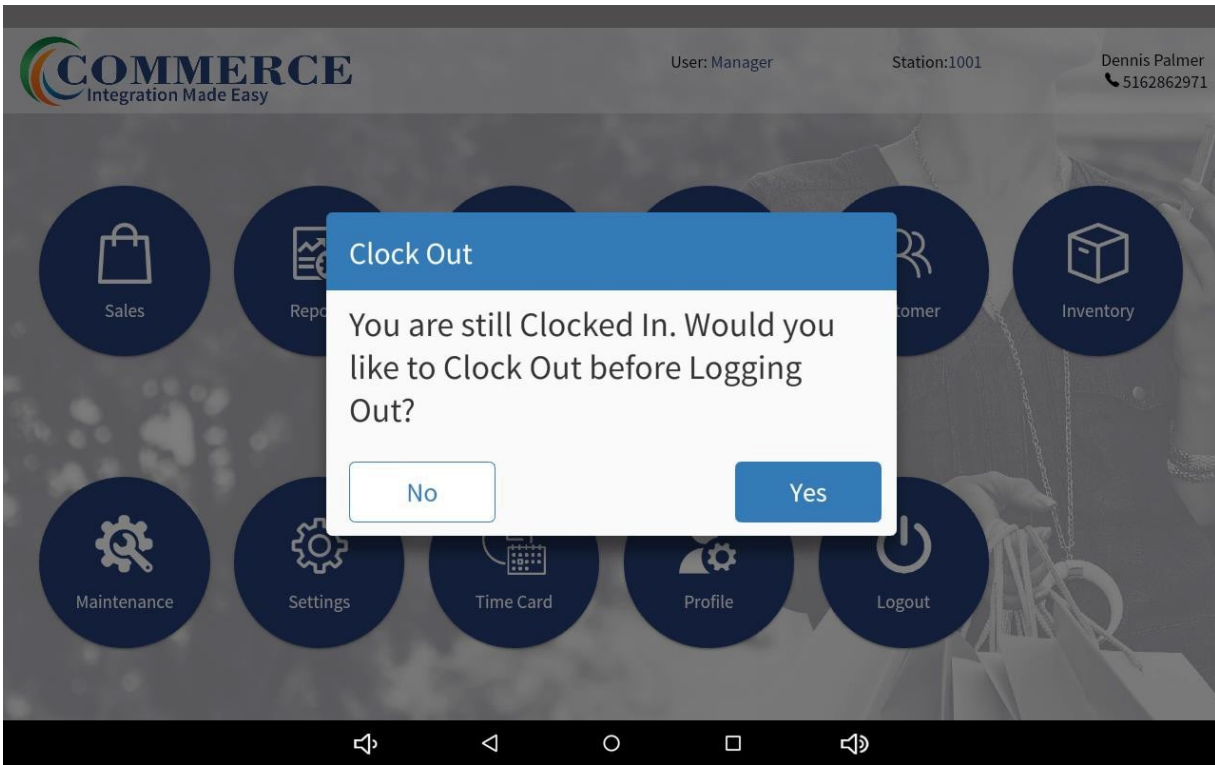
14. Logout
