There is a \$25 non-refundable application fee to Lilly Pond Foal Rescue required to process an adoption application. This fee must be included with the application and is payable by check or cash.

This application may be denied for any reason and is subject to approval by all board members.

If the application is denied, no reason will be given, but all applicants are welcome to reapply after 90 days of a denial if they feel their situation has altered enough to be considered for approval once again.

Lilly Pond Foal Rescue reserves the right to conduct a background check and to turn away any applicant

Lilly Pond Foal Rescue encourages potential adopters to become preapproved and submit an application early. An approved application is valid for one year from the initial date of approval.

The Lilly Pond Foal Rescue adoption fee varies from animal to animal and is subject to change.

Please read over the following policies prior to filling out the application and ensure you are in concordance with all, please remember foals have different fencing and care requirements than adult equines:

Lilly Pond Foal Rescue makes no representations or warranties concerning any horse offered for adoption or foster; including, but not limited to, the condition, health, temperament, soundness, or fitness for a particular purpose. Applicant understands and agrees that Lilly Pond Foal Rescue, it's officers, directors, representatives, volunteers, agents, servants and assigns, are not liable for any representations or misrepresentations concerning any equine offered for adoption or foster through this program; all

information listed on the website, lillypond.info, and/or any divisions thereof, in regards to any particular equine.

Lilly Pond Foal rescue reserves the right to make periodic visits to check on the health, care, training and well being of any fostered or adopted equine.

If any deficiencies are found in the care or stabling of the equine, Lilly Pond Foal Rescue reserves the right to relocate the animal if the deficiencies are not immediately corrected.

Lilly Pond Foal Rescue reserves the right to relocate any equines in the Foster Program at the sole discretion of Lilly Pond Foal Rescue.

A Transfer of Ownership Contract will be determined after one year and all Policies have been met by the Adoptee/Foster Applicant.

If any adopted equine is offered for sale, Lilly Pond Foal Rescue will be notified and given a one week right of first refusal.

No adopted equine shall be sold or transferred at any auction, horse broker, feed lot or slaughter destination.

Foal Requirements:

Lilly Pond Foal requires that in order for you to adopt a foal you must meet very specific qualifications.

You must have owned a horse previously.

You must have high quality fencing; no high tensile or barbed wire. We prefer this for adult horses as well. Foals also require 3-4 board fencing or gate panels.

You must have an active relationship with your vet and farrier, and must have their support of bringing a foal into your program. They also will need to vouch for the care you provide your current horse.

You must have a barn with stalls on your property in order to adopt foals. Foals must be constantly monitored in order to provide them with the same care and attention their mother's would provide. Foals are also prone to illness at young ages, and must be monitored to catch any potential problems early.

You must presently own horses. Foals require socialization and interaction with other horses in order to learn how to be a horse and participate in a herd. Other horses, particularly adult horses, are also necessary in order to teach foals manners they would ordinarily learn from their mothers.
