- WHEREAS, the Summit Lake Paiute Tribe is organized pursuant to Section 16 of Indian Reorganization Act of June 18, 1934 (48 Stat. 984) as amended, with the Articles of Association, and approved by the Secretary of the Interior on January 08, 1965, granting certain powers of the Summit Lake Paiute Council; and
- **WHEREAS**, the Summit Lake Paiute Council is the duly constituted governing body within the boundaries of the Summit Lake Paiute Reservation; and
- **WHEREAS**, the Summit Lake Paiute Council has been organized to represent, develop, protect and advance the views, interests, education, resources, and general welfare of the Summit Lake Paiute Tribe membership; and
- WHEREAS, the Summit Lake Paiute Tribe's Articles of Association grant to the Summit Lake Paiute Council certain sovereign powers including the power to seek funding from Federal agencies like the U.S. Department of the Interior Bureau of Indian Affairs, through Public Law 93-638 contracts to improve the welfare and education of Tribal members; and,
- **WHEREAS**, the Summit Lake Paiute Tribal Council appointed the 4 enrollment committee members to serve a term of no more than three years. Term of office is from April 2016 to April 2019.
- NOW THEREFORE BE IT RESOLVED, the Summit Lake Paiute Council, the governing body of the Summit Lake Paiute Tribe, hereby appoints the following members to serve on the Enrollment Committee, Christine Harjo, William Cowan, Nedra Crane and Lorieta Cowan.
