# **SEA-JUICER** Terms and Conditions

Please read all the terms and conditions carefully

## 1. Booking

- 1. A booking is taken as provisional & held for 7 days until Sea-Juicer Charters receives the following:
- Deposit or payment as defined in section 2 below.
- Customers full name, address, telephone number or email address.
- Upon receipt of all the above Sea-Juicer Charters will confirm the booking either by email or post
- Terms and conditions of booking apply to all bookings confirmed to the customer by Sea-juicer Charters and by entering into a confirmed booking the customer agrees to be bound by them.
- Any correspondence will only be with the person who has made the booking.

#### 2. Deposit or Payment

- 1. A deposit of £150 is required for booking the whole boat. Or £35pp for individuals The remainder of the fee is payable on the day
- 2. Please note we can only accept cash on the day of trip as payment for the remainder of the fee. Sorry, no credit cards or cheques.

# 3. Cancellations by Customer

- 1. More than 4 weeks before the booked date then the deposit or payment is returned.
- 2. 4 weeks or less before the booked date then the deposit or payment is forfeited.
- 3. 2 weeks or less before the booked date then full charter cost is still payable.
- 4. Gift Vouchers become invalid if the booking is cancelled by the customer at any point before the booked date / this also includes any trips booked by others as a gift.
- 5. If the trip is cut-short and a return to the harbour is requested by the customer then the full fee is payable.

### 4. Cancellations by Sea-juicer Charters

- 1. The customer must telephone Sea-Juicer Charters the evening before (6.45PM 7:15PM) the trip, to check that the weather is going to be suitable for the planned trip. On rare occasions the charter may get cancelled on the morning of the trip if the weather forecast has changed overnight.
- 2. Sea-Juicer Charters decision is final regarding the weather & sea conditions. We do try to fulfil as many trips as possible however safety & sea conditions take priority.
- 3. Sea-juicer Charters cannot be held liable for any loss incurred by the Customer if the trip has to be cancelled.
- 4. Sea-Juicer Charters reserves the right to alter a planned trip with regards to the fishing and weather conditions, e.g. a long range trip may have to change to an inshore trip.
- 5. Because of insurance rules, a small amount of low strength alcohol will be permitted on board, NO SPIRITS. any alcohol allowed on board is at the skipper's sole discretion. It is your responsibility to inform all members of your group about this prior to the charter.
- 6. Any Drug or alcohol abuse will mean an immediate return to harbour with full charter cost still payable.

## 5. General

- 1. Any medical or physical conditions which may affect a customer must be reported at time of booking.
- 2. Any injury sustained during a charter must be reported to the skipper on the vessel & on day of the charter.
- 3. The Skipper can cancel the trip if on arrival, if the skipper considers any passengers unfit to go, through drink, drugs or present a danger to the boat or others on board. Your payment will be forfeited. In all events the Skippers decision is final.
- 4. Children under 16 years old will only be taken by prior agreement & with their parent / guardian accompanying them.
