Cochrane Motion to Include the PSA Test for Men into the Medical Care

"BE IT RESOLVED that the Town Council of The Corporation of the Town of Rainy River hereby supports the Town of Cochrane in requesting that both the Federal and Provincial Governments move to have the PSA test for men included in the national health care system and that it be made available for all Canadian men at no charge and that the Government make every effort to have this become a reality sooner than later as every day that goes by another 11 men will die of this avoidable disease."

Eye Care in Ontario

Resolution #21-026 - Gerry Pasloski – Neil Ivall

"WHEREAS every day optometrists take pride in helping their patients see clearly and preventing blindness; and

WHEREAS for over 30 years, the Ontario government has refused to formally negotiate with optometrists; and

WHEREAS in 1989, the Ontario government paid \$39.15 for an eye exam and in 2021 (32 years later) they pay an average of \$44.65; and

WHEREAS this amount does not come close to covering the cost (including rent, staff, utilities, equipment, taxes and supplies) to provide an eye exam; and

WHEREAS this is not sustainable for optometrists and the Ontario government continues to ignore eye care; and

WHEREAS optometrists are left with no choice but to end access to eye care for millions of Ontarians as of September 1, 2021;

NOW THEREFORE BE IT RESOLVED that the Town Council of The Corporation of the Town of Rainy River hereby supports the Ontario Association of Optometrists in calling on the Ontario Government to commit to a binding, formal negotiation process—the same way they do with other health care sectors—to ensure quality eye care for everyone in Ontario, and

THAT this motion and a letter of support be distributed to the Ontario Association of Optometrists, the Honourable Doug Ford Premier of Ontario, the Minister of Health Honourable Christine Elliot, the Honourable Greg Rickford, MPP (Kenora—Rainy River), the Honourable Andrea Horwath (NDP Leader, Official Opposition), Steven Del Duca (Leader of the Ontario Liberal Party), all municipalities of the Rainy River District, the Association of Municipalities of

Ontario (AMO), the Northwestern Ontario Municipal Association (NOMA) and the Rainy River District Municipal Association (RRDMA)."
