Officer Elections for President and Vice President

Both positions will serve a two year term and you must be an Active Member who are current on Annual CNRE dues. They perform the following duties:

Section IV – Duties of Officers:

1. **Duties of President:** The President:

- 1. Shall be the chief executive officer of the Association.
- 2. Shall call the meeting to order and preside over meetings of the Association.
- 3. Shall have the floor at all times at all meetings unless he surrenders it.
- 4. Shall take notice of all motions and seconds to motions. Shall count votes with one other active member, who cannot be an officer or a nominee.
- 5. Shall make necessary legal notifications to attorneys or defendants.
- 6. Shall co-sign all financial reports. Shall, in case of emergency, make temporary decisions in the best interest of the Association, until such time as those decisions can be discussed and changed if necessary based on the vote of the officers and/or active members.
- 7. Shall see that the resolutions and orders are carried out.
- 8. Shall be replaced by the Vice President in the President's absence or disability.

2. Duties of Vice President: The Vice President:

- 1. Shall, in the absence or disability of the President, perform as the President.
- 2. Shall be available to the President for counsel about Association business. Shall be responsible for keeping an open line of communication between all members.
- 3. Shall notify the other officers of information provided by the President. Shall preside over committee chairpersons, therefore being a committee liaison to the membership and other officers.
- 4. Shall act as Sergeant at Arms and keep order at all meetings.
- 5. Shall ensure parliamentary procedures are followed. Shall serve as an informed source about association rules, Bylaws and governing documents.
