Action 01: Financial Updates.

The total collection including previous balance in the General Account amount to \$5899.83 and the total expenses is \$458.66. Thus, the current balance in General Account as of June 2019 is \$5441.47. The entire collection in Nepali Education Account (NEA) with previous balance is \$3601.39, and the expenditure is \$0.00. Therefore, the current balance in NEA is \$3601.39. Furthermore, the total collection with a previous balance on Temple Account as of June 2019 is \$192,053.67, and the expenditure of the month is \$12,189.75. So, the Temple Account has a balance of \$179,863.92.

Action 02: Endorsement of Amended Bylaws:

Per article XIV of the existing OHRC Bylaws, the current Bylaws are amended and endorsed on July 14, 2019. According to article XIV, OHRC Bylaws may be amended or repealed, or new Bylaws adopted by the Directors at any meeting by the affirmative vote of not less than two-thirds of all the Directors of the Corporation. The amended Bylaws was tabled on the OHRC Board of Directorate meeting for the endorsement. Board of Directorate agreed upon adopting the changes in the existing OHRC Bylaws. 100% of the board of directorates vote in favor of the change. Thus, effective July 14, 2019, OHRC is guided by the amended Bylaws.

Action 02: Bylaws Update and OHRC Election:

Effective July 14, 2019, OHRC has adopted some changes to the existing Bylaws. The following modifications impact the upcoming OHRC 2019 election:

1. Board of Director Service period: The Chairperson and all Board of Directorates shall serve for three (3) years. However, nothing herein shall be construed to limit the Board's right to reelect the Chairperson. The Chairperson may not be an employee of the corporation.
2. Election and Vacancy: Election: See from old bylaws. In the event of resignation, retirement, disqualification, death, disability, or removal from office, for any reason whatsoever, of any officer of the Corporation, the vacancy so created shall be filled by the Board for the unexpired term.

With the amendment of their existing Bylaws, the OHRC election is postponed until July 2020.
