Bloomfield Police Department Monthly Report for January 2020

This is the monthly report for the Month of January 2020 from the Bloomfield Police Department. It is the police department's goal to keep the citizens of Bloomfield Township/Village informed as to the police department's activities, statistics, and community projects. It is very important that the citizens be aware of the various concerns that have and are occurring within our community.

On Monday, January 6th at approximately 11:52am officers responded to a residence in the 1900 block of Briar Ridge Rd for a battery complaint. At the conclusion of the investigation a charge of disorderly conduct was forwarded to the Walworth County District Attorney's office for a 45-year-old Lake Geneva man involved in the incident.

On Tuesday, January 7^{th} at approximately 11:29am officers responded to a residence in 300 block of 2020 Hwy H for a burglary complaint. This remains an active investigation – information surrounding this incident has intentionally been withheld.

On Friday, January $10^{\rm th}$ at approximately 7:44am officers responded to the intersection of Chicago Drive and Green Road for a vehicle versus tree property damage only crash. At the conclusion of the investigation a 23-year-old Genoa City female was issued a traffic citation for unreasonable and imprudent speed.

On Saturday, January 11th at approximately 5:12pm officers attempted to initiate a traffic stop for a traffic violation at the intersection of Park Rd and Clover Road. After a very short pursuit the driver fled on foot from the vehicle which he had just parked in the parking lot of the Upper Crust. At the conclusion of the incident a 30-year-old Lake Geneva man was arrested then confined in the Walworth County Jail for three active arrest warrants and related offenses. Charges of vehicle operator flee/elude a traffic officer, display false registration plates, and non-registration of a vehicle have been forwarded to the Walworth County District Attorney's office. Additionally, the driver was also issued a citation for operating after suspension.

On Saturday, January 14th at approximately 3:08pm officers responded to a two-vehicle property damage only crash near the intersection of Daisy Drive and Wisteria Road. At the conclusion of the investigation a 23-year-old Delavan man was issued traffic citations for automobile following too closely and operating a motor vehicle without insurance.

On Friday, January 17th at approximately 4:08pm officers responded to two-vehicle property damage only crash on Hwy 120 at the Hwy H intersection. At the conclusion of the investigation a 46-year-old Salem man was issued a traffic citation for driving too fast for conditions.

On Saturday, January 18th at approximately 12:40am officers responded to the 300 block of N2020 Hwy H for a disorderly conduct complaint. At the conclusion of the investigation an 18-year-old Walworth woman was arrested then confined in the Walworth County Jail. Charges of criminal damage to property and disorderly conduct have been forwarded to the Walworth County District Attorney's office.

On Friday, January 24th at approximately 9:09pm officers responded to a single vehicle property damage only crash on Hwy 12 near the Pell Lake Drive overpass. At the conclusion of the investigation a 47-year-old Twin Lakes woman was issued a traffic citation for driving too fast for conditions.

On Saturday, January 25th at approximately 11:44am officers responded to the area of Bloomfield Road in the area of Brevers Lane for a single vehicle versus tree crash. At the conclusion of the investigation a 17-year-old Lake Geneva woman was issued a traffic citation for driving too fast for conditions and operating a motor vehicle without insurance.

On Sunday, January 26th at approximately 5:55pm officers executed a traffic stop on Hwy 50 in the area of Eastside Road for a speeding violation. At the conclusion of the traffic stop a 27-year-old Mosinee man was issued traffic citations for speeding, operating after suspension, and operating a motor vehicle without insurance.

On Friday, January 31st at approximately 8:48pm officers responded to the area on Hwy 120 and Hwy H for a hit & run property damage only crash. At the conclusion of the investigation a 30-year-old Lake Geneva man was arrested for operating left of center, operating a motor vehicle while intoxicated 1st offense, posses open intoxicants in a motor vehicle, and hit & run.

During the month of January 2020, the Bloomfield Police Department responded to 781 calls for service compared to 698 calls for service during the month of January 2019. During the month of January 2020, the police department affected 126 arrests for various violations of Bloomfield Municipal Ordinances and Wisconsin State Statutes compared 86 arrests during the month of January 2019.
