#### Tannenbaum Forest Last Weekend

The magic continues for just one more weekend. The Tannenbaum Forest, despite the pandemic and a bit of snow on Saturday, has been popular.

Yes, numbers are down compared to previous years, but those who visit the Forest are happy to have the opportunity to visit the Forest. One volunteer who worked in the Forest on Saturday told us, "Everyone is so, so appreciative. They understand that Santa can't be here in person and so they take photos with the photo ops, but they are just happy to have something Christmassy to share with their kids."

Elise Heitmann, Main Street Amana events coordinator, reported that visits to the Forest this year so far have been below half of what was seen last year, but then 2019 was a banner year for the forest. Last weekend for example, 158 people stopped by on Friday, 564 visited the Forest on Saturday and 477 on Sunday. Last year over 2,000 people visited the Forest on Saturday and over 1,000 on Sunday, the third weekend it was open, though last year the weather was ideal and that day both Santa and live reindeer were at the forest.

Even so volunteers and merchants are pleased the forest is open and certainly so are our visitors. We stopped a young couple with two toddlers in tow on Friday. Andrew told us, "It's really become one of our annual holiday traditions. We come down, have lunch here, go see the forest and do some shopping, then drive over to my folks' for the weekend. "From Des Moines they stop here, while on their way to Marion for the weekend. "We really look forward to it!" He added.

The Forest will be open Friday 11 a.m. - 5 p.m.; Saturday 10 a.m. - 7 p.m.; and Sunday 11 a.m. - 4 p.m.

Trees may be taken down Monday through Wednesday Dec. 21 – 23 from 8 a.m. until 4 p.m. Please, If you decorated a treeat the Tannenbaum Forest remove all your decorations during this time.

## Assault Reported in Amana: Sheriff States

lowa County Sheriff Rob Rotter reported that on Thursday, December 10 they received an emergency call from Debbie Cecak, Amana, that an unknown, white, male entered her bedroom and began punching her. This was at 4411 I Street, Amana, at approximately 1:24 a.m. Dec. 10.

According to Cecak the intruder entered through an unlocked door and likely left the same way. He entered her room while she was asleep and began punching her, she reported. Cecak screamed, the intruder then left the house. Cecak was treated at the scene for minor injuries by lowa County Ambulance, EMTs. Cecak did not get a good look at the assailant as the lights were off. There are no suspects. Nothing in the home has been discovered to be missing. The area has been canvassed.

### Income Levels Required in Iowa County for Utility or Rent Assistance How HACAP can Help

lowa County residents who need help paying their utility bill or their rent must take steps to find that assistance.

The first step is to contact the utility company, landlord and or bank and tell them about your situation. They may be able to work with you to create a payment plan or may have other information to help.

A second call should be made to the lowa County Social Services office at 319-662-4245. The office is open Monday through Friday from 8 a.m. until 4:30 p.m. They can provide information and resources.

One resource is the Iowa County General Relief Fund, funded by Iowa County tax dollars and managed by Iowa County Social Services. It provides short term assistance to Iowa County residents for rent, utilities, burial expenses, food. However, to qualify a person must meet the standard as set by the Iowa County General Relief ordinance, which as Iowa County Social Services explains means: a single individual qualifies if he or she makes \$300 or less per month; a couple qualifies for assistance if they make \$361 or less per month; and a family of four if they make \$495 or less. Meaning a single person has to make less than \$3,600 per year to qualify for such assistance in Iowa County. A family of four would have to make less than \$5,643 per year to

Iowa County Ministerial Alliance, located in Williamsburg, PO Box 21 Williamsburg, D. Dove, 515-520-1944 may be able to help with rent assistance and with other forms assistance. This is a group of churches that work together to fund a program. The Amana Church has an emergency fund for helping neighbors and church members in need. Contact the Amana Church administrator for more information at 319-622-6155.

Call HACAP for utility/ energy assistance, help applying for low income housing or housing support, help in weatherizing a home, support for veterans, food assistance, child care assistance, help for single mothers and pregnant women, family counseling, elderly medical and housing assistance, mental health care and more. Contact HACAP at 319-393-7811. HACAP is a nonprofit community action program working in partnership with LIHEAP, Feeding America, United Way and donors across Iowa. It serves 9 counties including Iowa County, Benton, Linn and Johnson County.

### PLEASE HELP CHILDREN IN **FOSTER CARE & THEIR FAMILIES**

The holiday season has begun. It looks and feels different to us all in one way or another. 2020 has been more than challenging, with its unrest, instability, fears, and losses in varying degrees.

While holidays typically bring people closer together, this can be a difficult time for children involved in the child welfare system who are not able to spend this time with their biological families.

Court Appointed Special Advocate (CASA) volunteers can step in, helping make sure children stay meaningfully connected with their siblings, families and communities. They stand by the child's side while in foster care, providing a consistent presence and ensuring he or she are kept safe and their needs are met. The children need someone who can get to know them and their unique situation even after their case

Appointed by a Judge, CASA volunteers' first priority on cases is to advocate for keeping families together whenever safe and possible. When that is not possible, CASA volunteers recommend that children live with another relative or close family friend to ensure that they can maintain connections to their family and community. CASA volunteers get to know the child or sibling group on an individual level and speak with other important people in the child's life, such as their parents and family, teachers, therapists, foster parents and more. With the information they gather, they develop a holistic understanding of their circumstances and needs, and make recommendations to the court.
