This newsletter brings important information regarding changes to trash services and annual dues impacting all homeowners.

We also welcome any input regarding whether to hold our annual picnic in August.

Please read the information from our interim treasurer regarding new dates for payment of our annual assessments.

We will begin using a new trash and recycling service beginning July 1 and will be sending additional details regarding the transition with Waste Connections of Colorado (mail & email), but here are a few key highlights:

The new contract is for 5 years; we will not be raising our current assessments this year; homeowners will continue to have one trash and one recycling bin and we will still have dumpster days!

The last date of service with Republic Services will be on **June 24, 2021**. On that date, please leave your bins outside and Republic will pick up the containers. We will provide dates when the new service will drop off new trash bins soon.

We will send a letter the last week of May to include more details on the new trash service.

Also, as we are conveying much of this information via email, if you know of neighbors who are not on our email list, please encourage them to sign up so they don't miss any information.

### **Annual Dues**

There will be a change to when you receive your invoice for our annual dues (\$495).

Our fiscal year is July 1 to June 30, and invoicing on June 1 falls into the previous fiscal year and creates a bookkeeping issue.

We can remedy this by moving the invoice date to July 1 (due by August 1) so that all recorded payments will now fall into the correct fiscal year.

After reviewing the covenants and bylaws, we feel this change to the policies and procedures is consistent with our governing documents.

Mark your calendar for June 5-6. The dumpster will be delivered to the Andover Glen park entrance on Layton St.

Please break down as much as possible any items you dispose of, as well as walk your items to the front of the dumpster rather than just pitching them in.

To avoid filling the dumpster with tree branches, etc., Monster Tree Service will be at the park entrance June 5 from 10:00 AM to 01:00 PM to shred yard debris for free. We will also be able to use the mulch for our common areas.

The paper shredder initiative will not happen until the fall.
