The Significance of 50 Percent

A Message From Your President-Jessi Colgrove

You have probably heard it said that if a state's membership drops below 50%, they are no longer recognized as an association. It's a rather arbitrary concept, but I saw the impacts of decreased membership firsthand at the National Convention in St. Charles this past August. This year, two candidates were running for the office of National Secretary. On Saturday morning, the sitting secretary took a roll call of delegates by state before the voting could commence. After she finished with Wyoming, the delegates from Washington stood and asked, "but what about us?" They were told that because their state's membership no longer met the 50% threshold, they were not eligible to vote. They lost their place at the table...and they lost their voice.

Nebraska ended the 2016-2017 dues year with 67% membership. That is still 18% away from losing our charter, but that number could be met easily enough. There are currently 296 COF employees in the state and 198 of them are NASCOE members. If only 52 of them drop their membership or retire and aren't replaced with new members, Nebraska will lose its charter. With so many of our employees eligible for retirement, this could become a reality.

Thank you to those of you who have been loyal members. I know that you do your best to help us maintain our numbers. We appreciate all of your efforts as you promote our association and do what you can to help us recruit new members so that Nebraska doesn't lose our place at the table...our voice.

In the hustle and bustle of the Christmas season, I wanted to take a few minutes to remind everyone of the January 1, 2018 submission deadline for all scholarship deadline and DSA nominations.

scholarship applications must be submitted online no later than January 1. Applications must be submitted using the official application on the NASCOE website. Letters of recommendation and the most recent posted transcript shall be required to be submitted with the application no later than January 1. Applications submitted without these documents will be disqualified.

All nominations for Distinguished Service Awards shall be electronically submitted no later than January 1 on the official nomination format provided on www.nascoe.org.

State winners are eligibile to be considered for area winners. Area winners are eligible to be considered for the National winner in each category. Associate members are not eligible for DSAs. Any member of the Association may make a nomination.

2017 NASCOE Convention was Historically

Awesome

The 2017 NASCOE National Convention was held in St. Charles, MO from August 2-5, 2017 and it was Historically Awesome! There were 18 people from Washington DC in attendance and this was a record number! Keep reading to see what all they had to say.

Bob Stevenson – Acting Chief of Staff

The Farm Bill, Conservation, Credit and research are working to improve service. Maintaining local staff in communities is important. In the reorganization with 7 missions in the USDA we are the ones on the ground. There are 23,000 employees (FSA, NRCS, & RMA) and we have a responsibility to leave the planet better than we found it. FSA has paid out 13 million in ARC/PLC payments and 4 million in CRP payments. Nothing will really change – there is just a new look for Washington DC.

We have smoother operations with less cost. It takes a full team effort and a unified team. We have an online portal for FSA. NRCS and RMA are working to streamline the programs. We will maximize resources to work with greater efficiency to improve customer service and to increase efficiencies. Stated that Secretary Perdue is an outcome based leader and is very proud of all employees and the work they do. Also stated "honest" data needs to be used to evaluate the work being done.

Chris Beyerhelm - Acting Deputy Administrator

We are seven months into the transition. We help the producer but we also do economic development and create jobs and wealth. Investing in communities is important. We have been dealing with fires and drought. Clean water and air are important and people need to be educated on why USDA-FSA invests money into water and air. Educating people will make a difference in their lives.

How important is our Agency? We need to tell people our story. Twenty two billion dollars is being invested in Ag Development. Rural Development is very important. The new SED's are starting to come in. Our staffing was at 98% before the freeze. We are facing an uncertain budget with a 22% cut in the proposed Ag Budget. FSA is a "boots on the ground agency" and can't afford to take anymore cuts.

FSA has 200 approved hires and possibly another 200 external positions coming.

It is important when listing the open positions that no changes are made to the job description and opening. Any (even small) change that is made and the position will have to be re-classified – delaying the posting and hiring of the position. By not changing the position description this will create an express lane for hiring. It has been noted that succession planning is something that needs to happen so offices aren't left with a gap in service and learning when someone retires or leaves the agency. It is important to make people feel good about what we do and make them feel valued.

A Leadership Training 201-301 course is coming for COT's and FLOTS. There is also Counter Skills training for PT's coming and the Train the Trainers phase for that course is happening now.

In the first year of the Workforce Engagement survey FSA was rated 154th in top places to work. In the second year FSA was 74th, then we were 54th and now we are rated 2nd in top places to work behind NASA. Eight thousand employees took the survey. (continued on page 5)

Your opinions are important. If you see mistakes in the handbooks – let Chris Beyerhelm know. They are committed to improving and updating the handbooks. Do you like the newsletter? Speak up and let them know your likes and dislikes.

"Blazing to Rio" was a huge success and now we are "On Our Way To The Moon"!

Web-TA is now getting closer to getting the data to be used for our staffing needs. There are too many "Common Programs" entries. It needs to be more specific to tell our story and tell what we do. We should all be more disciplined in Web T&A and ALL overtime should be reported. COFs are always a priority when it comes to the budget.

And for beginning farmers – the biggest problem is getting land access. Non-operating Land Owners (NOLO) were mailed 20,000 postcards to contact the NOLOs about working with beginning farmers and ranchers. Sixty of the cards were returned and twelve are matched in the Nationwide program. They are also looking for mentors nationwide – local people or retired producers – to help mentor a producer that is struggling whether it be with financial advice or crop/livestock knowledge.

As for the new Farm Bill – Programs will be tweaked and there will be some new programs. If anyone has ideas for the next Farm Bill those can be submitted through NASCOE. BTO has three phases and length of service awards will now be coins.

Brad Karmen - Acting Adminstrator for Farm Programs

Political Business doesn't stop our jobs – we must keep the ball rolling. Secretary Perdue has been a breath of fresh air and makes quick decisions.

The first decision was on the wildfires. Emergency Haying and Grazing was opened and then the 150 mile zone was added.

Farm Programs: Much going on with Price Support, Commodity Loans, and Dairy. Production and Compliance has had the ARC/PLC program. We have done a great job making payments on time.

ARC-CO yields have been a problem. If you have disagreed with the yields – let them know. Producers have more faith in the RMA yields. NASS yields are used first – RMA yields second. Switching to the RMA yields first would not make that much difference. There will always be differences between counties whether NASS or RMA yields are used. And even a small difference between counties can make a large difference in the payments.

Four disaster programs will go on forever – LFP, LIP, ELAP, and TAP. Some grazing dates may change.

Appropriations Bill – 2018 – Cotton will fall into ARC/PLC.

MPP (dairy) Program will change for 2019. LFP extending certification.

PT's are now a "7" and we have a "Key" PT in each district.

There are 60 people training to lead the County Skills training. Hopefully PT's can be trained in groups of 25 but this is up to the individual states how it is carried out.

National Leadership training has trained 1900 Office Managers. There are 417 left to complete the training. The Aspiring Leader Program is working on contract issues with the developer so this can continue. GS & CO employees can apply or be nominated.

Rahda Sekar - Chief Financial Officer

She has been with the Agency for two years and three months and has FSA's interest in her heart. Wes Daniels expressed his appreciation on how Rahda has been open to our concers regarding staffing. She visited a county office to get to know what we do. You need to know your farmers to get money for our mission. We put food on the table – it is a story – not a numbers game.

Customer Service doesn't come cheap and it can't be automated. They must know we need help! For 2018 the president's bill will die - but it was only really a baseline. Congress will help us - we need good conversations going around the hill. We should be ok with the budget we will get most of what we asked for. But we must capture what needs to be done and assess what we are doing and what we are not doing. We need to indicate what we can't get done and put numbers to it so we can get the staff we need. From the NEBRASCOE Cookbook

Christmas Crack Crunch

- 1 c. Butter
- 3/4 c. Brown Sugar
- 1 bag Chocolate Chips
- 1 sleeve of Saltine Crackers
- Any toppings you would like (pretzel pieces, nuts, M&Ms, candy canes etc.)

Heat oven to 400°. 9x13 pan with aluminum foil and put saltines on top of foil. Heat butter and sugar in a boil, to stirring constantly until sugar is melted and toffee starts to leave the sides of the pas (5 minutes). Pour toffee over top of the crackers. Using a fork, straighten any crackers move; spread evenly. Bake for 5 minutes. Remove from oven spread chocolate chips on top, as chocolate chips melt, carefully spread evenly. Add any toppings you might like (pretzels are my favorite). Cool completely and break into pieces. Enjoy!

Hiring freeze focus in 2018 will be lifted. Hiring will go much faster now with using EXPRESS LANE! Use it!

25% of the federal employees and 20% of the county office workforce is eligible to retire now. That will jump to 40% for federal and 44% of COF employees by 2022. In 2022, 70% of DDs will be eligible to retire. Nobody wants to lose a new employee – the challenge is in succession planning – focus on investing in the workforce. We must focus on the talent and the long term of knowledge transfer and succession planning.
