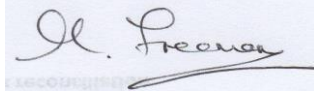

The application site is ... remote from services, facilities, amenities and public transport links. ..It has not been demonstrated that there is an essential need for residential accommodation on the site in order to deal with the essential care of animals or the needs of the business at short notice.*
