#### **Board of Public Affairs Report** -

Council was informed that the main line to the well and the electric has been installed but they are still waiting on the new pitless adapter.

#### Finance Committee -

Money has been appropriated in the water and street department for the purchase of a truck and plow. The department is looking at purchasing a used Suburban, however due to the council rules regarding the limitation on the amount of a purchase order that the Mayor can sign without council's approval, some of the vehicles located are sold prior to being able to obtain council approval. The committee suggests that council preapprove a set amount to be used to purchase a vehicle.

Ordinance 14-1113, Agreement with Logan County Water Pollution Control AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH THE LOGAN COUNTY WATER POLLUTION CONTROL DISTRICT TO PERMIT THE DISTRICT TO USE THE VILLAGE'S WATER TOWER INFRASTRUCTURE FOR THE PUPOSE OF THE PLACEMENT AND USE OF THE DISTRICT'S SCADA ANTENNA IN THE VILLAGE OF RUSSELLS POINT, OHIO AND DECLARING AN EMERGENCY IN THE VILLAGE OF RUSSELLS POINT, OHIO.

# **CITIZEN COMMENTS:**

A. <u>Mary Forgione, 204 Oak Crest Ct., Russells Point</u> Ms. Forgione asked the status of completion on the Indian Lake/Great Miami River Open Space Project. Mayor Reames noted that the seeding for the project will not take place until next spring.

## **OLD BUSINESS:**

- A. <u>CDBG Grant FY2013 for Storm Sewer & Catch Basin Repair</u> The repairs have been completed and the area has been re-seeded.
- B. Personnel Policy

The new personnel policy will go into effect on Wednesday, November 2, 2014. Clemans Nelson will attend a meeting with all employees to review the manual and address any questions they may have.

C. Agreement with Ms. Janice Rogers, 316 Westview

Mr. Eshenbaugh stated that the agreement with Ms. Rogers should be signed by the end of this week. The agreement gives Ms. Rogers until April 1, 2015 to make the necessary repairs to be in compliance with the village's ordinances. Otherwise, Ms. Rogers will need to remove the structure by May 1, 2015.

D. Available Grant Writing Services with Gatchell Resources

It was suggested the Gatchell Resources be contacted to see if there may be any grants available to repair or replace the damaged playground equipment.

E. Wind Turbines

In regards to discussions in the previous council meeting, it was decided that Mr. Eshenbaugh will prepare a letter supporting the efforts of the Logan-Hardin Neighbors United, opposing the Scioto Ridge Wind Project.

Mr. Eshenbaugh will also be working on preparing an ordinance for the village to adopt restricting windmills within the Village of Russells Point.

## **NEW BUSINESS:**

A. Leaf Dumpsters

Council agreed to place (4) 20 yard dumpsters in front of the Municipal Building for residents to dispose of their leaves.

*Mr.* Dave Wallace made a motion to place the dumpsters behind the Municipal Building. The motion died for lack of a second.

B. Eastern Shawnee Tribe Meeting

The Chief of the Eastern Shawnee Tribe will be in Ohio from November 7th through the 13th and would like to meet with Council. Council agreed to have a Special Meeting on Tuesday, November 11, 2014 at 7:00 p.m. in the Municipal Building.

C. Property Forfeiture, 417 High Ave., Russells Point

The village has been offered the property located at 417 High Ave. through property forfeiture. The village has received prior properties through this procedure at no cost, however due to recent court decisions; the village may be required to pay the back taxes on the property which totals over \$23,000. It was decided that the village will not act on the offer.

# D. Office Closures

The village office will be closed November 11, 2014 for Veterans Day.

# **Council Minutes, November 3, 2014**

Council was asked if they would like to close the offices the day after Thanksgiving as has been done in previous years.

*Mr.* Tom LaDow moved to close the Municipal Building on Friday, November 28, 2014. Employees are to use their banked leave time to receive pay for this day. Ms. Kelly Huffman seconded the motion.

E. Golf Cart Seat Belts

Mr. Wallace suggested that the village review its golf cart ordinance prior to the spring season. He noted that there is nothing in the ordinance stating that seat belts are required. Mr. Eshenbaugh explained that the ordinance is written that golf carts are defined as a motor vehicle and the Ohio Revised Codes states that all motor vehicles must have seat belts.

*Ms. Joan Maxwell made a motion to adjourn the meeting.* The meeting was adjourned at 8:26 p.m.
