

IBHA PROCEDURE TO SUBMIT RULE PROPOSALS

REVISED 3-17-18

1. The IBHA Standing Committees, Charter Delegate Committee and Executive Committee review Rule Proposals submitted from members and determine if they benefit all members of IBHA on a national level.
2. Proposals must be submitted on proper proposal form, as available from IBHA, no later than October 30 of year prior to the IBHA convention.
3. A proposal form is to be completed in its entirety and any and all documents, data and information required are to accompany the form.
4. Upon receipt, the proposals will be documented, numbered and verified for completion and all information required is attached to the proposal.
5. The proposal will be analyzed for feasibility, member and/or association benefits and any consequences that may arise from acceptance or rejection. Proposals must be beneficial to the membership, charter clubs, horse show exhibitors or the association. They are not to be designed or construed for only a minority of those involved.
6. If deemed probable and/or acceptable, the proposal will follow the flow chart and be scheduled for discussion at the proper Standing Committee Workshop to become part of “new business” introduced at the Standing Committee Meeting which is open to convention attendees.
7. After following the Flow Chart procedure, should a proposal be accepted to become an IBHA national rule, such new or revised rule shall become effective with either the next published rule book (either printed or on the IBHA Web site) or on January 1st of the year following the Convention when the proposal was accepted.

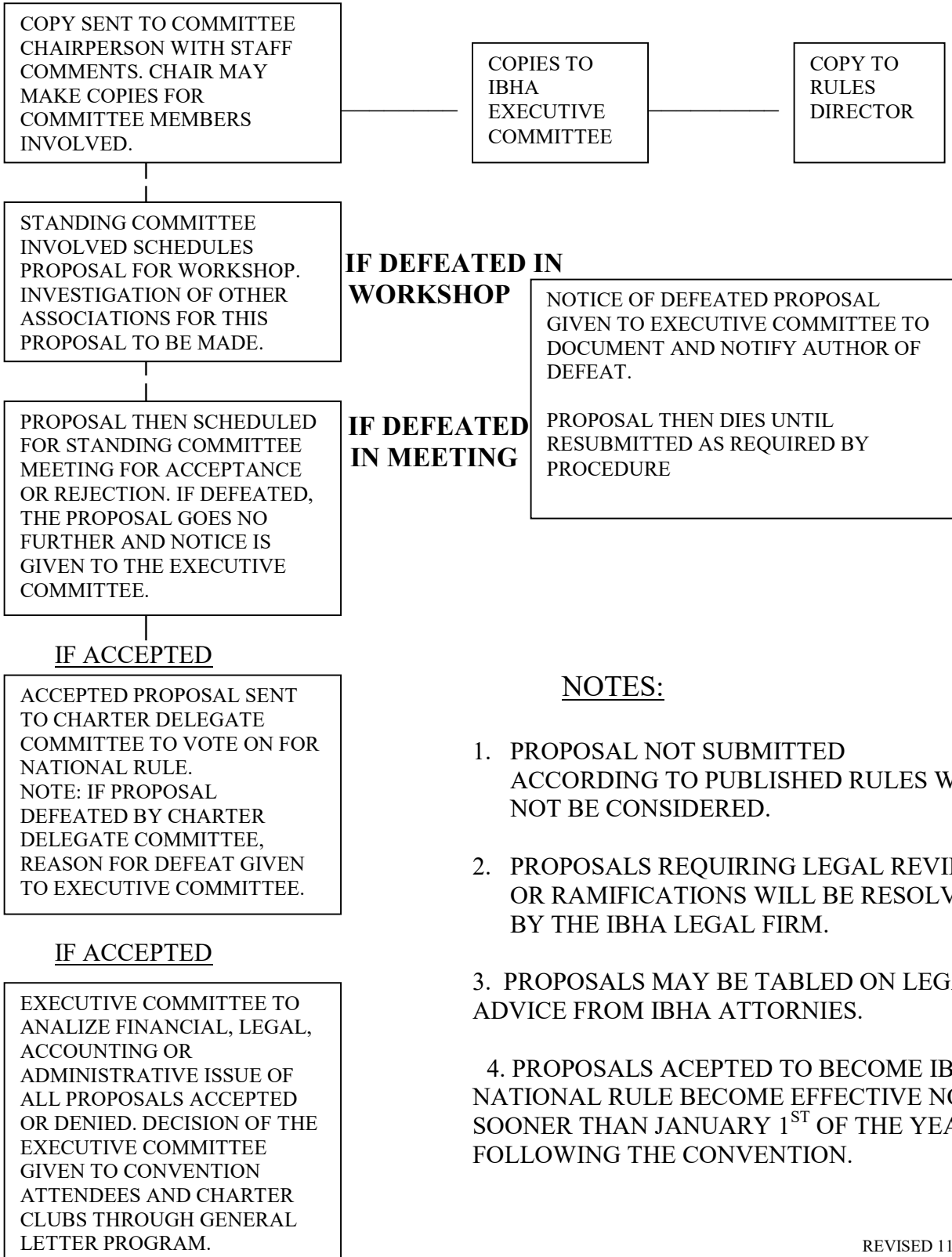
NOTE: The above procedure is to be adhered to with no exceptions.

Only current members in good standing may submit a rule proposal. Proposal must be submitted no later than October 30 prior to the IBHA Convention.

This form to be used only for a new horse show class requested for lifetime points and national awards. The following requirements will pertain:

1. Proposed new class must be tried on a local level and results of such class to be included with this proposal. There must be interest shown for more than just a minority of exhibitors.
2. Any new class not tried or not submitted with actual entries will be declined. Author proposing a new class would benefit from having other charter clubs try the class and including their results with the proposal.
3. If proposed class is one of another association, the rules for the class are to be included with this request. If no other associations has such class a complete spelled out set of rules must be enclosed with this proposal.
4. Should a new class proposal be defeated it may be resubmitted the next year but if defeated again may not be submitted again for at least two years.
