

COMMUNITY SERVICE PROGRAM RULES

- Arrive at the assigned pick-up point **on time.**
- Participants are subject to a pat down and must pass through a metal detector prior to the start of the program.
- No firearms, knives, explosives, or other dangerous items are permitted.
- Possession or consumption of alcohol, any controlled substance, or prescription drug is prohibited.
- Smoking or possession of tobacco products is prohibited.
- Seat belts must be worn at all times while riding in vehicles.
- No obscene words or gestures.
- No physical contact is permitted.
- Treat everyone with respect at all times.
- Bring a meal and beverage with you.
- Dress for outdoor participation. Youth must follow the dress code.
- No jewelry of any kind is permitted.
- No radios, cell phones, headphones or other electronic gadgets are permitted.
- The crew supervisor will be permitted to assign rules as he/she sees fit to ensure the safety and orderliness of the crew at any time.



The Honorable Kevin W. Dunn is one of four Common Pleas Court Judges in Medina County. Judge Dunn was appointed in 2013.

The Medina County Juvenile Court has jurisdiction over all cases involving persons under age 18, including those categorized as unruly, delinquent, abused, neglected or dependent.

In addition to serving as our county's Juvenile Judge, Judge Dunn is the Probate Judge.

COMMUNITY SERVICE PROGRAM LOCATION

Community Service operates out of the Medina County Juvenile Detention Center located at **655 Independence Drive** in Medina. (Next to the Medina County Jail)



From the North: Take U.S. 42 (Pearl Rd.) south to Medina. U.S. 42 becomes Court St. in Medina. Follow Court St. south for 2 miles to the second traffic light south of Public Square: Lafayette Rd. Turn right and go south on Lafayette Rd. for 1.5 miles to Independence Dr. Turn right and go north on Independence Dr. for 500 feet to the Juvenile Detention Center on the left side (west) of the road.

From the South: Follow State Rt. 3 (Wooster Pike) north to the City of Medina. Rt. 3 becomes Court St. in Medina. Follow Court St. north for 1.5 miles to the second traffic light: Lafayette Rd. Turn left and go south on Lafayette Rd. for 1.5 miles to Independence Dr. Turn right and go north on Independence Dr. for 500 feet to the Juvenile Detention Center on the left side (west) of the road.

PROGRAM OVERVIEW

The Community Service Program, operated by the Medina County Juvenile Court, is a way for youth to “pay back” the community. The Community Service Program provides work experience to the youth served by the Juvenile Court. The Court has defined community service work as labor provided to a non-profit or governmental agency. The participant is not compensated for services. The program operates throughout the year.

PROGRAM STAFF

Community Service supervisors are employees of the Court. A supervisor will contact you and schedule you for service. Program staff will address any questions and scheduling issues you may have.

FREQUENTLY ASKED QUESTIONS

How much does the Community Service Program cost?

The cost of Community Service is \$10 for every four hours scheduled. This fee will be assessed by the Medina County Juvenile Court.

How do I schedule my Community Service hours?

A Community Service Supervisor will contact and schedule you for service.

When are the Community Service Hours?

Community Service operates between the hours of 4:00 p.m. to 8:00 p.m. Wednesdays and Thursdays, and 8:00 a.m. to 4:00 p.m. on Saturdays.

Your child must promptly arrive at the Juvenile Detention Center by the program start time. You are required to pick up your child no later than 10 minutes after the program end time.

What if I don't have a ride to the Community Service Program?

Parents and/or Guardians are required to arrange transportation of their child to and from the program. However, if personal transportation is not possible, you may contact program staff at (330) 764-8408 ext. 2048. You will be charged a \$10 fee each way.
