A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CISCO, TEXAS, TO ENTER INTO AN AGREEMENT WITH THE STATE OF TEXAS THROUGH THE TEXAS DEPARTMENT OF TRASPORTATION FOR THE TEMPORARY CLOSURE OF HIGHWAY 6 FROM 10TH STREET THROUGH 3RD STREET ON DECEMBER 6, 2018, FOR ACTIVITIES ASSOCIATED WITH CISCO CHRISTMAS PARADE.

I. Consider and Discuss Westbound Water Rates.

Mr. Archer said that the city was contractually able to increase rates each year and that rates had not been amended since 2008. He went on to say that the cost per 1000 gallons to Westbound was around \$2.07 per 1000 gallons, but that rate would likely change with the completion of the new treatment plant. He recommended a rate of \$4.40 per 1000 gallons. Councilmember C. Johnson stated that he had issues with charging Westbound less than the citizens pay per 1000 gallons for their water and would like to see them pay at least the "over 12,000 gallons" rate. He also took issue with the actual contract and was not entirely sure it was binding at this time. He suggested tabling the item until the City Attorney could review the contract and make recommendations.
