

Clubhouse:

Your monthly minimum will be \$55 for April through October (except for junior members). You must charge a minimum of \$55 each month (unless you have prepaid) as you will be billed this amount automatically each month. Any additional charges will also appear on each statement. We are offering an annual prepayment of \$385 to be paid with your annual dues. Statements will be issued on the 1st of each month showing the balance of monies owed or the balance of credit remaining. If your account becomes more than 60 days past due, your golfing privileges will be suspended until it is brought current.

You will be issued an account number which will be yours for the length of your membership at Tall Oaks Country Club. When making purchases you will be asked to sign a receipt requiring your name and account number. You will receive a copy of that receipt and one copy will be kept on file at the club. Cash and credit cards will also be accepted at the club any purchases made with cash will not go against your monthly minimum.

Clubhouse Rental Terms and Conditions:

Advanced reservations must be made with the board of directors. A \$50 deposit is needed and will be refunded if the clubhouse and grounds are left clean. The rent is due when the reservations are made. The clubhouse may be closed from November 1st to April 1st of each year and the renter must obtain all necessary Dramshop/Liquor insurance during this period.

Guests:

All guests must pay all applicable fees. A local resident may play golf as a guest at Tall Oaks Country Club up to three times a year; we encourage local residents to become members. Guests from outside a 25-mile radius may play as a guest of a member up to a total of 10 times in any one year.

The limitations of playing golf do not apply to an overnight guest of a member who lives outside the limitations set forth above. Bonafide overnight house guests of a member are allowed full privileges of the club by paying the proper guest fees, and, when the proper arrangements have been made by the member.

If a child of a member brings a guest to golf, the child and the guests must be of high school age, unless accompanied by an adult member.

Members using the picnic area are expected to leave the area clean. To have guests at the lake or picnic area, you must be present during the time your guests are there.

Members are responsible for their guests at all times.

Private Carts:

To own and store a motorized golf cart you must be a stockholder. All carts to be used at tall oaks Country Club must be approved by the cart committee.

It is mandatory for the member to contact the cart committee before buying a cart to be used at Tall Oaks Country Club to assure there is a cart space available and the cart meets club specifications. You must have rented a cart stall to use a private motorized cart at Tall Oaks. Carts are for the use of the owner only and cannot be used by other members or guests. Members riding with a cart owning member do not have to pay trail fees. Due to a problem with electrical hookups in the cart shed, no new electric carts will be allowed.

To operate a private cart without adult supervision, the driver must be at least thirteen years old. This regulation is to cover possible liability to Tall Oaks Country Club, the Board of Directors, and the cart owners. Club rental carts will be available only to children who have obtained their driver's license. Please note: Tall Oaks Country Club's insurance does not cover the personal golf carts stored at the cart sheds your personal cart must be insured under your own policy.

Cart Rentals:

No more than 2 rental carts per foursome. Players are not allowed to each rent a cart and only use 1 seat. No alterations to the carts is permitted, such as turning up the speed governor.

Minor Children:

Children under the age of 12 shall not be left without adult supervision in or around the clubhouse or putting green at any time.

Children under the age of 12 are not allowed to fish or to be around the lake without adult supervision. This lake is very deep and has very steep sides. No swimming is allowed by anyone, at any time.

Parents are responsible for the behavior of their children and minor guests on Tall Oaks Country Club property.

Course rules:

Everyone must sign in before teeing off.

Soft spikes or no spikes only

Members and guests are asked to cooperate when signs are posted such as "Course Close" or "No carts today" as well as directional signs around the greens. Please use cart paths or drive in the rough as much as possible. Cross the fairways at a 90-degree angle. Do not move forward on the fairways, as this will cause the mowers to mow improperly and may create bad playing conditions.

If you play before 9:00 AM on days other than Saturday, Sunday or holidays, expect to have the inconvenience of sprinklers on the greens, tees, and fairways

A bullhorn will be sounded from the clubhouse if foul weather is spotted. All golfers on the course are recommended to return to the clubhouse or to find shelter under the brick gazebo.

Course Rules (Continued):

Monday is reserved for women only after 4:00PM

Tuesday is reserved for the men only after 12:00PM

These rules apply from May 1st to October 1st. Please be off the course by these times.

All club golfing events have priority.

All players must register before playing. This is for your benefit in the case of it an emergency. Members having guests must register them by placing their name and amount of green fees paid on the guest register.

Players must begin their play on #1 tee or #6 tee if no one is playing on number 5. No one is allowed to start on #6 if the course is crowded.

Practice on or to any greens other than the putting or chipping greens is prohibited. There was a practice green and sand trap between #3 green and #6 tee. Please use this for practice chipping. The putting green at the clubhouse is only for putting and chipping from the fringe.

The golf course and clubhouse are closed only when posted.

In the interest of all, golfers should play without delay. No golfers should play until players in front are out of range. If you are searching for a ball or if golfers behind you are playing faster than you, please signal them to play through. When hole is been completed, golfer should continue to the next tee where scores can then be registered on the scorecard. Remember, "fivesomes" are not allowed unless it is approved and determined by the Clubhouse Manager that it will not be disruptive to general play. All these actions help to speed up play and make the golf experience enjoyable for one and all.

Just remember, please smooth over holes and footprints you make in our bunkers. Don't forget to repair your ball marks on the green, and maybe one made by others, and restore all divots including those made accidentally due to practice swings, particularly on the tee boxes. When driving carts, especially when the course is wet, observe all course rules by staying in the rough and away from greens and tees.

Dress Code:

This dress code policy applies equally to all members, guests of members, green fee players and other patrons of the golf course and is applicable for all areas of the club including the golf course, practice range, and clubhouse.

- Traditional golf attire is recommended for all golfers.
- No clothing with offensive phrases or graphics will be allowed.
- Sweaters including turtleneck mock turtleneck crew neck or V-neck sweaters are acceptable.
- Muscle shirts, men's tank tops, tube tops or halter-tops are not allowed.
- Tailored pants or dress shorts are acceptable.
- Denim pants or shorts are discouraged but will be allowed if they are tailored and neat and are not "short shorts".
- Gym shorts, cut-off shorts, beachwear, tear-away pants, sweatpants or shorts, cycling shorts, or spandex shorts or pants are not permitted.
- Proper soft spike golf shoes or golf sandals, running shoes or soft flat soled footwear are acceptable.
- Baseball, soccer or other shoes that have cleats are not permitted.

The Clubhouse Manager may refuse play to anyone that does not meet the intent of this dress code.

Membership

Age is as of April 1 of the current year (EX: A person turning 36 years old is still eligible for 35 and under if their 36th birthday takes place after April 1)

Family Includes all children currently living at home, up to 24 years of age (see rule above) regardless of school attendance
