#### **Traffic V&T**

- 29 Traffic Tickets issued the Month of January along with supporting Depositions.
- 22 of the tickets almost 76% for school zone speeds
- 13 warnings issued for traffic infractions.
- We received a letter of thanks from the Town of Covert for our good working relationship that we have fostered with the Town of Covert Court.

#### **Community**

- We have created a Facebook page that will be used by the Interlaken Police Department to make the agency more transparent to the community. We will make announcements on the page not only to inform the public but to help them understand what we do on a daily basis. With more and more of our citizens turning to social media I believe this will benefit not only our residence but persons who want to visit, travel and or re-locate to our Village.
- At no cost to the Interlaken Village Police Department or the Village we have signed up for a mass communication system called NIXLE. The company can send 500 messages every second. The messages can be sent via, text message or email and subscribers can sign up through the company through text, email or by phone. I am in hopes to have the system up and running by the end of February. This system is free for public safety and could have been used for our boil water notice.

### **Training**

- Sergeant Leon Anderson was certified in CPR and the use of an AED thanks to our Interlaken Volunteer Fire Department.
- As a Civil Service Sergeant Training needs to be set up with in one year of being promoted to the position. -The training is a one time training for Supervisors; the training is good for all ranks including Chief of Police. The course is approx. 105 hours.
- Chief of Police test is being offered by the Seneca County Personnel. Sergeant Leon Anderson's application and money to pay for the test had to be in by February 2, 2013. He has completed the application and paid the fee. He will be taking the Civil Service Police Chief's exam on Saturday March 23, 2013 at the Seneca County Office Building.

### **Grants**

- We have spoken to the NYS Traffic Safety Board Coordinator for our region. We will be able to apply for grants in March 2013. The Grants are for Buckle up New York and Selective traffic enforcement.
- On Friday February 15, 2013 Sergeant Leon Anderson will be driving to Albany to pick up the Data-Master that we were granted by DCJS. This will allow us to run tests for suspected persons in DWI cases here at the Village of Interlaken Police Department and allow other agencies to utilize the instrument if needed.

### **Awards**

- On February 21, 2013 Sergeant Leon Anderson will be honored by the Seneca County Stop DWI program for his arrests of DWI's here in the Village of Interlaken.
