

COMMISSIONERS PROCEEDINGS

July 17, 2017

The Jewell County Commissioners met July 17, 2017 at 8:30 a.m. with Commissioners, Steve Greene, Mark Fleming and Keith Roe present. Carla J. Waugh, County Clerk was present for the meeting.

Randy Hofmeier, CPA of Lindburg, Vogel, Pierce, Faris Chtd., reviewed the draft 2018 County budget. The budget hearing was set for August 14, 2017 at 10:00 a.m. The proposed mill levy is 104.388 which is down 9.673 mills from last year's mill levy of 114.061.

Joel Elkins, General Superintendent, discussed the two tire bids from last week. He said that after reviewing the bids in detail it was discovered that Randall Coop's bid did not include the specified tires that was listed in the bid request. Mark Fleming moved to rescind the motion of accepting Randall Coop's bid of \$23,320 because they didn't bid tires specified. Steve Greene seconded the motion. Motion passed. Steve Greene moved to accept the bid from Lloyd's Sinclair for \$24,370 for the tires as specified. Keith Roe seconded the motion. Motion passed unanimously.

Joel Elkins had quotes on used loaders from Foley Equipment: 2014 Caterpillar 924K Wheel Loader with trade in of the Kawasaki Z60 for \$115,800 or a 2015 Caterpillar 924K Wheel Loader with trade in of Kawasaki Z60 for \$125,800. Mark Fleming moved to purchase the 2014 Caterpillar Wheel Loader with trade in of the Kawasaki Z60 for \$115,800. Steve Greene seconded the motion. Motion passed unanimously.

Joel Elkins discussed a resident that blades the county road with his tractor and dozer blade leaving a hazard in the road.

Angela Murray, Health Nurse, discussed a health hazard with Darrell Miller and the County Commissioners as the Board of Health. Don Jacobs, Sheriff, was also present for some of the discussion.

The minutes of the July 10, 2017 County Commissioners meeting were approved.

Don Jacobs, Sheriff, discussed personnel.

Steve Greene moved and Keith Roe seconded to approve abatement number 2285. Motion passed unanimously.

Steve Greene moved and Mark Fleming seconded to appoint Keith Roe as the voting delegate for Kansas Association of Counties Annual Conference, Mark Fleming as the 1st Voting Delegate and Steve Greene as the 2nd Voting Delegate. Motion passed unanimously.

Mark Fleming moved that the proper officer sign that the county is an unzoned county for the application of Bill Foster to build a sign. Keith Roe seconded the motion. Motion passed unanimously.

Chris Petet, Custodian, discussed replacing light fixtures. He also discussed surplus equipment to be sold.

The meeting was adjourned at 11:41 a.m.
