Minutes of the Interlaken Village Board of Trustees meeting held on Thursday December 17, 2020 in the Village Hall and via Go-to-Meetings

Mayor Richardson called the meeting to order at 6:30 pm with the Pledge of Allegiance.

APPROVAL OF MINUTES: Motion made by Barr to approve November 12, 2020 minutes 2nd Pepper, carried.

Public to be Heard: M Bergren asked if we were still under mandatory conserve water – DPW response yes, it is unknown the amount of snow or rain will come over the winter months.

Library: No report from Director. Mayor Richardson briefly talked bout the proposed parking lot. DPW continues with leaf clean-up.

Fire:

November had 11 calls.

The traffic control hand lights came in the members liked them so I ordered 6 more so we have 2 on each truck

Back up camera has been repaired on 504 also looked at a light tower malfunction

Went with Wes and looked at situation at the lake not sure we could get a big truck close enough to the lake maybe our mini not sure but we would sure be willing to try gave him a submersible pump that might be some help. Guys are more than willing to help if we can

We were called to a structure fire next to village hall on the south found pellet stove burning in the hopper due to blower malfunction got lucky could have been much worse everyone involved did a great job. County codes was called.

We gave out 4 thanks giving meals with everything needed to make a thanks giving meal we get names from local organizations

Sold 48 Christmas trees all had good time

Myself and the Dept hopes everyone has a Merry Christmas and stays safe and healthy thanks for your support this year it sure has been challenging to say the least

DPW received a UFPO request for fire department – Chief indicated that the phone poles were rotting.

Water:

Bac T sample Nov 17th to Waterloo lab: winterized hydrants, Nitrate sample Nov 19,

- : Mai from Hunts looked at well and water plant
- : Grinder pump in lake quit Nov 20 put in back up, ordered new 1 hp Grinder pump and has been installed
- : Nov 23 & 24 well pump having trouble keeping up with demand
- : Nov 24 Clay valve came to adjust surge valve at water plant, working better but not perfect, has slight weep when off
- : Nov 25 called county health about well not producing, they contacted the state. willies dropped a 1000 gal in our well
- : Nov 26: put 2nd pump in the lake, thank you to the Flagg's for letting us use their electric.
- : Nov 27 & 28 Hauled water in from Ovid via longs trucking from Penn Yan. Thank you to Mike Snyder and the village of OVID for all the help!

Hauled in approx. 28000 gallons each day.: on Nov 30th we got about 3/4 of inch of much needed raid and the well was already improving

- : dec 2nd Well static level has come up about 4.5feet &has stabilized but still concerning. static level 4'11": Dec 3 creek started to run water again
- : NYS/homeland security offered a mobile filtration unit for 30-60days which i recently refused as we aren't in a dire situation right now as its available
- : Replace solenoid valve on pump 2.: Dec 4 install new 1hp. grinder pump in lake.
- : Shut water off at 2643 Cayuga St and the old Candido Building on Geneva st to prevent leakage: Arrange main line valves and fitting in garage
- : After a long search I found a replacement lock & handle assembly for the water plant at Watkins Glen supply for \$450 rather 7-800 lock smith
- : Dec 15 pulled PFO&PFAs and took to Microbic lab in Cortland
- : Can no longer get analog water meters, new digital meters require a \$950- reader and meters are 130 each would like to buy 12-24 meters & new digital reader

Motion by Kempf to purchase the reader and meters, second Barr, carried.

: would like the board to consider a new submersible pump called a ready 8 by Flyght Company approx. \$1000 xylem let us use one for 3 weeks and it worked great

Motion by Richardson to purchase submersible pump, second Pepper, carried.

Mayor, Hunt Engineers, NYS Dept. of Health and Seneca Co. Health met to discuss where the village could get water at the lake. Del Plato asked about drilling current well deeper – Mayor that could run into sulfur and contaminate the water.

Briefly discussed the RECAP Solutions vs Jay Grasso on surveys

Wes said that Seneca Co. Health has given us negative comments – this could help the village in getting more grant funds.

Sewer:

New dehumidifier installed at sewer plant.: I would like the thank Gary Covert for fixing heat at the sewer plant for free of charge needed a new pilot system

- : Ordered new injection pump, last one was on its last legs. It's turned all the way up and barely working:
- : Normal operation by Yaws and normal pumping by Brewers:

Streets:

Leaf cleanup, got leaf vac running and used it for ditches and culverts: x-mas lights put up, flags down: would like to order 10 new flags: Mike Welsh in for the lights: Josh Jacot got compressor running, but then it wouldn't shut down so he came back, called Maguire ford and chevy for truck pricing, haven't got a call back: serviced JD 4300, put plow on: got F 250 ready for snow: plowed snow, new street lights are up and saving us money: still shopping for tool kit(drills) probably going with DeWalt, most tools for money

Police:

Chief Anderson read his report

2 parking 1 tow for winter parking violations. Dodge serviced. Radar unit installed in Dodge (\$3k grant). Officer Deal has one more day of training. Reports filed with NYS; Audit reports are completed. Still working on police reform. Tax system down, back up now. Crossing guard contacted NYS DOT to get the school crossing lights fixed – noted that DOT made this a priority and fixed the lights. Per Wes, Cornell Local Roads Program said the village has the right to install signs. Chief Anderson said there needs to be a resolution

Motion by K Barr, second by C Kempf to approve the following resolution.
