Approval of Minutes: Review of Minutes Mike Wilkerson had questions about the verbiage of a motion made that Fruitland Special Service District is to stop accepting Residential and Commercial Water connections at this time. The board reviewed the audio and it reflected to be correct and no changes were made.

3)Chairman talked about the water haulers

Zach said he talked with Brock and he had told zach that pinon ridge fill station counts 10 customers as 1 ERC. We had no news if the Pinion Fill station was up and running yet. Discussion on putting a fill station by the well or following up with the commissioners to see if they could help put a facility in at the new road shed site. Possibility of circulating a petition around for potential water haulers to sign that could be presented to the commissioners. Going forward it was decided that a non-potable water sign be placed at the hydrant and a backflow preventer installed and that FSSD would continue to allow existing water haulers to haul from the office hydrant.

DECK BIDS:

No other bids had came in. Board reviewed Yeates Constructions Bid of 13,840.00 again. Yeates had requested that FSSD pays 50% down for material. Board recommended that staff lets Yeates know that it needs to be done in a timely manner and according to Duchesne County specs/Building code.

Mike made a motion to Award the new deck /porch for existing FSSD office bid to Yeates Construction in the amount of 13,840.00 by Jared second by Steve. Approved.

Zach asked the board if he was ok to work on the porch after hours as he works for Yeates construction on his days off. Board agreed that would be fine.

Jared Kesler Big G Update Jared said he talked to Shane Giles about the prior meeting and they discussed having two meters as well as the G selling water. Jared made a recommendation to make sure they have a backflow preventer and to sale the water as non-potable water.
