RULES & REGULATIONS

The following rules and regulations for the recreational area are for the benefit and protection of all members to assure safe and sanitary operation of the facilities. Your cooperation in abiding by these conditions will afford pleasant relaxation and recreation for all concerned.

MANAGEMENT

The Board of Directors has delegated authority to the Pool Management Company (**Atlantic Pool Company**), its representatives, and its staff for the enforcement of these rules and regulations. Parents will instruct their children to observe all rules and regulations and to obey the instructions of the lifeguards. **The Pool Management Staff will take whatever action deemed necessary for the safe and orderly operation of this facility.**

FACILITIES

The Swim Club consists of one swimming pool (25 feet in length) with a diving area and a swimming area consisting of six competition lanes, a separate wading pool, a bathhouse with showers and restroom facilities, picnic area (including a grill), and a parking lot.

POOL OPERATIONS

1. Pool hours:

While school is in session (May 26 - June 15, 2018 and August 28 - September 3, 2018):

Monday – Friday	4:00 pm to 8:00 pm
Saturday	11:00 am – 8:00 pm
Sunday	12:00 pm – 7:00 pm

When school is out for the summer:

Monday, Wednesday, Friday	12:00 pm – 8:00 pm
Tuesday, Thursday	11:00 am – 7:00 pm
Saturday	11:00 am – 8:00 pm
Sunday	12:00 pm – 7:00 pm

2. The pool will be closed because of weather conditions (below 70 degrees). The pool will also be closed whenever someone vomits or defecates in the pool. The pool water must go through a complete cycle through the filter system. This takes at least 4 hours.

3. The pool will be closed any time due to thunder, lightning, or any other inclement weather conditions.
4. Pool closings such as failure of pool equipment or vandalism will be announced on the website. Lifeguards must contact a member of the Board of Directors to make this announcement. The pool will also close if the phone does not work. Atlantic Pool will not furnish a cellular phone until the telephone is fixed. This situation is not covered by the insurance carrier for the Atlantic Pool Company.

ENTRY TO THE POOL

1. No person shall use the pool unless it is officially open and lifeguards are on duty. Persons entering or using the pool area other than during designated hours of operation, unless specifically authorized by a member of the Board of Directors, shall be considered trespassers and subject to criminal and civil prosecution.
2. No person shall be allowed to use the pool facilities until identified by the lifeguard with a current pool picture pass. Only members that are paid in full for their Glen Cove Swim Club and appropriate homeowners association dues will receive a pool picture pass to use the facilities. Season pass holders will also receive picture passes after proper payment and photographs have been remitted to the Swim Club Membership Coordinator.
3. Admittance to the bathhouse and pool will be refused to any person having a skin disease, sore or inflamed eyes, cold, nasal or ear discharge, communicable or contagious disease, open sores or wounds, or having excessive sunburn.

GUEST POLICY (also see separate Glen Cove Swim Club Guest Rules)

1. Guests must be accompanied and signed in by an adult (18 years and older) member only unless the guest is an adult caregiver for a member under the age of 18. This member is responsible for the conduct of his or her guests. This responsibility includes financial liability for any damages. There is a limit of five (5) guests per member.
2. Each member household that paid on time (by March 31) will receive a free 10-guest pass. After it has been used completely or if one is needed, members may purchase another 10-guest pass for \$20 or pay \$3 per guest.
3. A guest is a person who is not a member of the Glen Cove Swim Club and who does not hold a season pass.
4. People who do not live in a members' house such as friends and relatives are considered guests of fully paid members.

RULES

1. Swimmers and bathers should take a soap shower before entering the pool.
2. The following are **not allowed** in the pool or pool area:

Chewing of gum	Pets	Blowing of nose in pool
Glass	Street footwear	Profane language
Skateboards and bicycles	Rough play	Alcoholic beverages
Spitting	Spouting of water	
Roller blades	Radios without ear phones	
3. Persons unable to display to the lifeguard their ability to swim the length of the pool (i.e., 25 yards) will not be allowed in the deep water or the pool without an adult (18 years old or older).
4. To ensure maximum attention to pool safety by lifeguards, members are requested to stay clear of guard stands and not to converse with the lifeguards who are on duty in the chair or on the deck. The guards are there for your safety – NOT FRATERNIZATION.
5. There will be a 10-minute break every hour for those under 16 years of age.
6. Only one bounce on the diving board is allowed. Only one person is allowed on the diving board at a time. Dive in a direction straight off the end of the board. Do not hang on the diving board. The diving board may be closed when the pool is crowded so that members and their guests may use the full area of the pool for swimming. The diving area will not be used for general swimming without first closing the diving board.
7. Diving in the shallow area is not allowed.
8. No glass articles will be allowed in the bathhouse or pool area.
9. Flotation devices for children are not allowed in the pool unless an adult is accompanying and attending to the child when in use.
10. Rafts, beach balls, inflatable mats, fun noodles, and inflatable toys will be allowed in the main pool during lax times. The lax times will be at the discretion of the lifeguards and the Board of Directors.
11. The Pool Management and the Swim Club Board of Directors have the authority to exclude any person from the pool area for misconduct and failure to obey pool rules and

regulations. **Anyone under the age of 18 years old who is excluded from the pool will be required to have his/her parent or guardian accompany him/her before (s)he will be allowed back to use the pool.**

CHILDREN

1. An adult must accompany children under the age of 12 in order to use the pool facilities even if the child can swim the length of the pool.
2. Children age five and under are allowed to use the wading pool. Supervision of children in the wading pool area is the responsibility of the parents/guardians who must remain in the wading pool area with their child or children at all times.
3. There must be a ratio of one adult for five children while using the main pool.
4. Children in diapers must wear protective pants or swim diapers. Disposable diapers that are not designated as “swim diapers” are not allowed in the wading or main pool. If a child is in the pool without protective pants or swim diapers, the parent will be asked to remove the child immediately.

LOST AND FOUND

Lost articles will be placed in the lost and found area at the entrance of the pool bathhouse. Articles not claimed within seven days will be disposed. The Swim Club is not responsible for loss or damage to personal belonging, bicycles, or automobiles on the Swim Club premises.
